Parents gave unsatisfactory responses in the area of their ward getting admission in college as matter of pride (2%), availability of academic calendar& plan at the beginning of year(4.1%)& information (2.5%) of University pattern, accessibility PHYSIOTHERAPY college website (1.7%), timely declaration of exam results(6.6%)&Availability of hostels facilities(4.2%).
