# FEEDBACK ANALYSIS REPORT (2019-20)

# STUDENTS FEEDBACK ON CURRICULUM

A total of 33 subjects was covered in the feedback form for the BPT academic year by 1st & 2nd SEM CBCS, 1st year Regular, 2nd year Regular, 3rd year Regular& odd and Final year Regular& Odd batch students from 18th -20th August, 2020 through Google forms. There were a total of 10 questions regarding the syllabus, Study materials, contact hours for the theory & practical of each subjects, pattern & evaluation of exam, etc. was covered & after analysis, these feedback responses varied from satisfactory -Good - Very good. 50% of students in 1st year Regular batch gave satisfactory responses in the area of Size of syllabus in terms of skills, knowledge, concepts for Human Anatomy & Kinesiotherapy-1. There were also unsatisfactory responses in question regarding to the pattern of syllabus (1.9%); evaluation scheme of the syllabus (36.7% in biochemistry, 1.9% in KT-1); relevance of textbooks & reference books& distribution of contact hours for Human anatomy-2(3.7%) & Physiology-2(1.8 %) in the 1st & 2nd SEM CBCS BPT. In the 4th year Regular & odd batch, as well as unsatisfactory responses were found in questions related to syllabus(7.4%); patternof exam (7.1% in CBR,7.4% in Cardio respiratory sciences, 7.9% in MSK ,11.1% in Neurosciences) & distribution of contact hours in the course contents(3.8% in Neurosciences). In the MPT Academic year 2019-20, a total of 23 subjects were covered in the feedback form by the 1st &2nd SEM PG students which were filled by them on 4th September 2020. A similar set of 10 questions were filled by the MPT students & their overall response was Good- Very Good while unsatisfactory responses were found in the questions related to relevance of textbooks & reference books especially in the subject of Teaching Technology(25%) as well as satisfactory responses for the same in cardiovascular anatomy, physiology & pathology (91.7%).

After going throughthese particular analyses, a staff meeting was held with the principal & the above topics were discussed & the following steps were taken:

- Class coordinators were requested to explain the pattern of syllabus & the exam at the beginning of academic year.
- Teachers were requested to explain the students on exam evaluation by discussing points
  how an answer should be written, presentation skills, scoring marks smartly, how to
  present clinical topics, etc. as well as a few Assignment on paper solving, doubt solving
  lectures & topic presentation were asked to be scheduled.
- The Teachers were demanded to give the list of reference books &study materials after each topic completion.

good- excellent. Overall rating of teaching and learning in MGM School of physiotherapy was reported to be good- excellent by 82.2% students.

ATR: From the academic year 2019-2020, Credit Based Credit System Curriculum for the MPT program was implemented. This curriculum is student learning centric in nature. Choice Based Credit System is a flexible system of learning. The distinguishing features of CBCS are:

- It permits students to learn at their own pace.
- The electives are selected from a wide range of elective courses offered by the other University Departments.
- Undergo additional courses and acquire more than the required number of credits.
- Adopt an inter-disciplinary and intra-disciplinary approach in learning.
- Make best use of the available expertise of the faculty across the departments or disciplines.
- Has an inbuilt evaluation system to assess the analytical and creativity skills of students in addition to the conventional domain knowledge assessment pattern. The generic electives and discipline specific skill based electives enhance application of curriculum to real life situations, local developmental needs, employability and entrepreneurship.
- It helps to fulfill the well-defined learning objectives and build knowledge concepts, practical skills, and analytical abilities and broaden perspectives.

### 2. Infrastructure and facilities:

62.5 % students reported that lecture halls and laboratories were good. 90.8% of them thought that washrooms were poor- fair. 84.6 % students reported canteen and mess facilities, hostel facilities, and facilities for extracurricular activities were fair-good.

ATR: Infrastructural improvements were carried out to improve facilities offered at MGM School of Physiotherapy, with the addition of a seminar room, timely cleaning of wash rooms thrice a day and painting of all classrooms.

# 3. Teaching and learning methodologies:

79.1 % students reported that more than 70-84% syllabus was covered in the class. 97.1% students reported that teachers prepared satisfactorily-thoroughly for the classes. 97.5 % of them reported that the teacher's approach to teaching was fair-very good and that evaluation process was usually fair. 95 % students agreed that the institution provides multiple opportunities to learn and grow and the institute provided adequate opportunities for professional, social and mental growth.

#### ATR:

- From July 2019 University Examination evaluation process is digitalized to ensure transparency and avoidance of potential errors in evaluation.
- Potential learners were identified and remedial lectures were conducted to promote better understanding and enhance performance.
- Library: Internet facilities and increase the number of books available in the library
- Additional practical sessions are being carried out to improve hands-on skills
- Students were engaged in doubt solving tutorials to promote one-on-one discussion and enhance learning environment.
- Checklists were prepared for practical training and competency based evaluation was introduced.

# REPORT OF STUDENTS' FEEDBACK

MGMIUDPO puts their students above all. Their inputs and requirements are considered to be the most important integral part of the development of the institution as a whole. The feedback obtained with reference to various parameters provided to the students of the First and Second BPO are as follows:....

### • Extent of Syllabus of coverage of course:

31% of the total BPO students gave the feedback that the extent of syllabus of coverage of course is **Good** and 69% of the total students responded with **Very Good**.

**Conclusion:** Majority of the studentsgave the feedback that the Extent of syllabus of coverage of course is Good and Very Good. Hence the Institute needs to maintain the syllabus coverage methods.

#### • Depth of the course syllabus:

15% of the total students gave the Feedback that the Depth of the course syllabus is **Very Good**, 62% of the total students gave the Feedback that the Depth of the course syllabus is **Good** and 23% of the total BPO students gave the feedback that the Depth of the course syllabus is **Satisfactory**.

**Conclusion:** The syllabus of the BPO program is formulated by Rehabilitation Council of India.Majority of the Students gave the feedback that the Depth of the course syllabus is Good. Hence the Institute needs to maintain the depth of the syllabus by the Faculty.

## • Availability of material in text books:

15% of the total students gave the Feedback that the Availability of material in text books is **Very Good**, 54% of the total students gave the Feedback that the Availability of material in text books is **Good** and 31% of the total BPO students gave the feedback that the Availability of material in text books is **Satisfactory**.

**Conclusion:** Prosthetics and Orthotics Books are comparatively lesser in numbers and hence proper management of the same is sometimes hindered and this needs to be worked upon for better results.

#### • Interest created:

38% of the total students gave the Feedback that the Interest created is **Very Good** and 62% of the total students gave the Feedback that the Interest created is **Good**.

**Conclusion:** It can be safely assumed that almost all the students are quite satisfied with the methods used by the institution to develop interest among the students for the program.

#### • Utility for clinical applicability:

46% of the total students gave the Feedback that the Utility for clinical applicabilityis **Very Good** and 54% of the total students gave the Feedback that the Utility for clinical applicabilityis **Good**.

**Conclusion:** The BPO program at MGMIHS is still in a developing phase and hence the clinical applicability can be improved for further excellence.

### • Talk and chalk with black board:

61% of the total students gave the Feedback that the Talk and chalk with black board is **Useful**, 31% of the total students gave the Feedback that the Talk and chalk with black board is **Sometimes Useful** and 8% of the total BPO students gave the feedback that the Talk and chalk with black board **Needs Change**.

**Conclusion:** Majority students feel that the teaching methods involved with the black board are vastly useful to them. The institute needs to work up with those few who feel that this system needs change while maintaining current standards.

## • Power Point Presentation:

100% students report that the presentations used in the classroom are useful for them.

**Conclusion:** The Institute should maintain the current practise of using presentations.

## • <u>Library Facilities</u>:

54% of the total students gave the Feedback that the Library Facilities are **Very Good** and 46% of the total students gave the Feedback that the Library Facilities are **Good**.

**Conclusion:** The students are satisfied with the Library Facilities provided by the institute which the latter should maintain in the future too.

#### • Mentor System:

85% of the total students gave the Feedback that the Mentor Systemis**Beneficial** and 15% of the total students gave the Feedback that the Mentor System is **Not Beneficial**.

**Conclusion:** While the majority students feel that the Mentor System is quite useful for them in their problems, the institute should also provide better counsel for the few students who feel the need to improve the mentor-mentee system.

#### • Internal assessment:

92% of the total students gave the Feedback that the Internal Assessment **Helps to improve** and 8% of the total students gave the Feedback that the Internal Assessment is **Sometimes Effective**.

**Conclusion:** Almost all the students report that the current IA system is beneficial for their academic development and helps to improve their practice and knowledge-base.

### • University examinations:

60% of the total students gave the Feedback that the University examinations are **Very Good**, 30% of the total students gave the Feedback that the University examinations are **Good** and 10% of the total BPO students gave the feedback that the University examinations are **Unfair**.

**Conclusion:** Majority of the students are satisfied with the locker facilities provided by the institute. The institute should maintain these standards while simultaneously cater to any irregularities faced by the students.

#### • Suggestions:

#### • Extracurricular:

31% of the total students gave the Feedback that the Extracurricular Activities are **Very Good**, 54% of the total students gave the Feedback that the Extracurricular Activities are **Good** and 15% of the total BPO students gave the feedback that the Extracurricular Activities are **Adequate**.

**Conclusion:** Almost all the students feel that the Extracurricular Activities are up to the mark and hence the institute should continue to maintain these levels and standards in the above mentioned area.

#### • Canteen and Mess facilities:

46% of the total students gave the Feedback that the Library Facilities are **Very Good** and 54% of the total students gave the Feedback that the Library Facilities are **Good**.

**Conclusion:** The students are very happy with the services provided by the canteen and mess and the institute should ensure that both continue to provide such services in the future.

# • Hostel Facilities:

2 students reported the hostel facilities being **Good**.
