Chairperson commented that the biomechanical facility was exclusive to MGM Centre of Human Movement Science, Navi Mumbai and hence it was not possible to extend this study to Aurangabad Campus. However, multi disciplinary clinical field studies with MGM Aurangabad may be encouraged by the Director (Research).

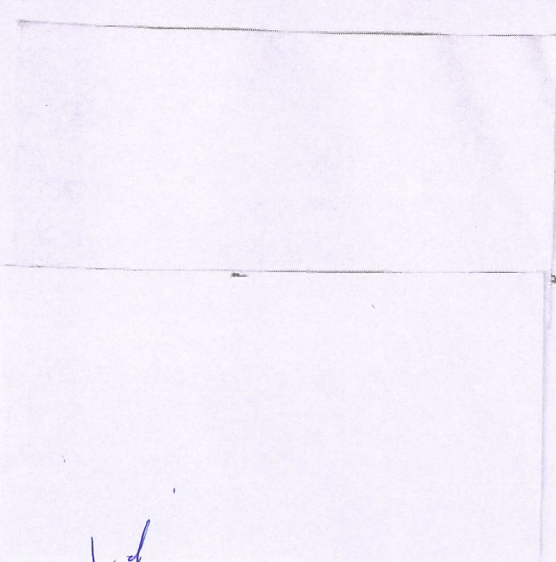



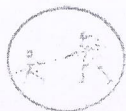
Before concluding the meeting the Chairperson and members expressed their concerns on the following points and advised the PhD scholars to follow them;

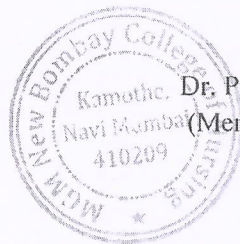
