AGREEMENT

AGREEMENT is made at CBD Belapur this 03<sup>rd</sup> day of September 2019 between Mrs. Manisha Vikas Sawant residing at Tulsi Residency Flat No 202, Plot No W93 to W95, Sector 19/20 CBD Belapur NaviMumbai 400614 (hereinafter referred to as the party of the First Part) and the MGM New Bombay College of Nursing having its office at 5<sup>th</sup> Floor, MGM Educational Campus, Plot No. 1 and 2, Sector -1, Kamothe, Navi Mumbai 410209 (hereinafter referred to as the party of the Second Part).

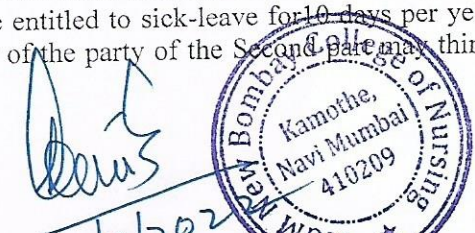
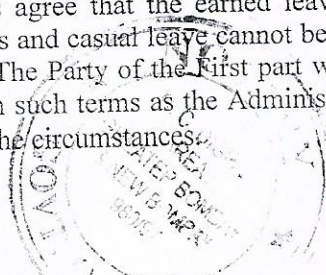


WHEREAS

1. The Party of the first partful fills the eligibility criteria for admission to the 2 years, MSc. Nursing programme (hereinafter referred to as 'the said course') and is desirous of enrolling in the said course offered by the Party of the Second Part.
2. The Party of the second part is the MGM New Bombay College of Nursing having its office at 5<sup>th</sup> Floor, MGM Educational Campus, Plot No. 1 and 2, Sector -1, Kamothe, Navi Mumbai 410209 provides the two years, M.Sc. Nursing programme. The Party of the First Part is a Constituent Unit of the MGM Institute of Health Sciences Deemed University u/s 3 of UGC Act, 1956, Kamothe, Navi Mumbai.
3. The Party of the First Part has requested the Party of the Second Part to grant financial assistance (without interest) towards the first year tuition fees of Rs.80, 000/- to enable the Party of the First Part to enroll in the said course. The Party of First Part agrees and undertakes to pay all the other fees in the beginning of each academic year.
4. The Party of First Part on successful completion of the said course of MSc. Will be qualified for employment to the approved post based on availability / vacancy in the post with the party of Second Part. The Party of the First Part has agreed and undertaken to join the employment to the approved post based on availability / vacancy in the post of the Party of Second Part and work with the Party of the Second Part for a period of 2 years. The Party of the First Part has further agreed and undertaken to repay the said amount of tuition fees sought as financial assistance in installments from the salary which would be received from the party of Second Part.
5. The Party of the Second Part has rendered financial assistance of Rs80000/- to the party of the First Part for enrolling in the said course. The party of the First Part has vide a Bond, Indemnity and Guarantee agreed to work with the party for a period of 2years and repay the said amount of Rs.80000/- in 23 installments as per the stipulated terms and conditions of the Party of Second Part.
6. The parties have now mutually decided to reduce the same in writing on the following terms and conditions:-

NOW IT IS AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS:

- I) The Party of the First Part agrees, undertakes and is bound by the agreement, bond and indemnity to work for a total period of 23 months from the date the Party of First part completes the said course. The party of the First Part will assume charge and join the employment within 3 days of completing the said course. The employment period may be extended for a further period from time to time as may be agreed upon.
- II) The Party of the First part shall be paid a monthly salary-----  
Of Rs. -----, from which an amount of Rs/-will be deducted (towards the installment for repaying the financial assistance) for a period of 22 months from the date of joining. The Party of the First Part shall therefore be paid a net monthly salary of Rs ----- After the aforesaid deduction for \_\_\_\_\_ months and a salary of Rsfor the balance period of \_\_\_\_\_ months.
- III) The Party of the First Part will be entitled to get leave as per the defined rules and regulations of the institute/hospital with full pay, after every 12months' regular service and will be entitled to casual leave of not more than 8 days in a year. The Parties agree that the earned leave cannot be accumulated for more than three months and casual leave cannot be taken for more than three consecutive days at a time. The Party of the First part will be entitled to sick-leave for 10 days per year and on such terms as the Administrator of the party of the Second Part may think fit in the circumstances.





IV) The duty timings of the Party of First Part will be for 8 hours per day. The Party of the First Part will be informed of the shift timings at the beginning of the month/quarter. The party of the First Part agrees to cooperate and assist at the time of natural calamities, during any emergency or urgency or wherever required by the Party of the Second part after the working hours without claiming any additional, remuneration by way of overtime allowance or otherwise.

V) The Party of the First Part will devote the whole office or working time and shall work faithfully, sincerely, diligently and efficiently and to the best of her ability and make her best efforts to use her knowledge and Skill in providing the best medical services and medical care to the patients.

VI) The Party of the First Part will diligently undertake and complete the administrative work assigned to her by Director/Nursing Superintendent/Ward In charge. The Party of First Part will not divulge or disclose to anybody any medical case papers, examinations details, reports of any of the patients.

VII) If the party of the First Part resigns from service and terminates this agreement before the expiration of the said period of 2 years or extended period, she will be liable to pay to the party of the Second Part a sum of Rs80000/-along with interest at the rate of 12% per annum as per the bond and indemnity/guarantee dated.-----The Party of the Second Part will be entitled to claim and recover from the Party of the First Part or from the sureties the amount proportionate to the balance service period with interest at the rate of 12 % per annum.

VIII) The Party of the First Part will not remain absent from the work without a prior intimation and without obtaining prior written permission of the concerned reporting authority of the institute / hospital or in his/ her absence, any administrator authorized for such permission.

IX) All the original documents and certificates of the party of the First Part will remain with the party of the Second Part till the entire financial assistance and interest in default is recovered. The original documents will be returned on after a declaration of the loan being repaid.

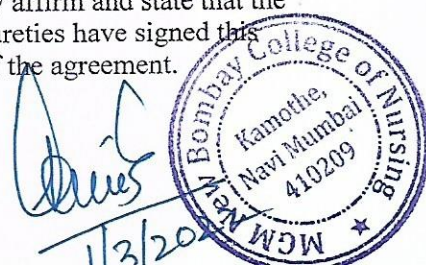
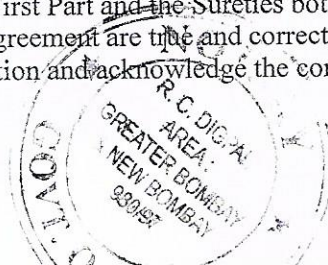

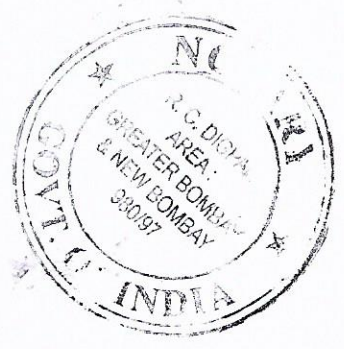

## GUARANTEE AND INDEMNITY
