**Sub.: Time to complete the Research Publication Analysis for the period from January 2006 to December 2018 and January 2021 to December, 2021 and Payment Schedule.**


The proposal of CIntelligence has been approved for an amount of Rs.224576.00 + GST Rs. 40424.00 = Rs. 2,65,000.00.
