

Memorandum of Understanding

This Agreement is made on 07 Feb 2022, by and between **Clinical Pharmacokinetics & Biopharmaceutics (CPB) Department, Wockhardt Research Center, Wockhardt Limited** having its Office at D-4, MIDC Area, Chikalthana, Aurangabad-431 006 referred as a party- A

And

Mahatma Gandhi Mission (MGM) Medical College & Hospital, N-6, CIDCO, Aurangabad, Maharashtra 431 003 referred as a party-B

The two parties, in a spirit of business cooperation, agree to sign this contract and pledge to fulfill conscientiously all the obligations stipulated in it.

NOW, THEREFORE, in consideration of the promise and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is mutually covenanted and agreed by and between the parties here to as follows.

MGM Medical College & Hospital signs this agreement with Party for a period of 05 years w. e. f 07 Feb 2022 to 06 Feb 2027. (Will be reviewed and updated accordingly)

Obligations of Party A:

- Party A is a pharmaceutical company based in Aurangabad that conducts BABE studies in all therapeutic areas.
- Party A is desirous of working with party B for the purpose of obtaining ethic committee approval from MGM's Ethics committee for Research on Human Subjects (MGM-ECRHS) for BABE studies conducted at their site.
- Party A shall submit their proposal to MGM-ECRHS at least 15 days prior to the scheduled EC meeting in the prescribed format.
- Party A shall facilitate monthly postings of students pursuing MD pharmacology, MSc Medical Pharmacology and MSc Clinical Research in MGM Medical College, Aurangabad to acquire practical perspective of theoretical concepts relevant to their domain.
- After obtaining EC approval from MGM-ECRHS, Party A shall notify regarding initiation of the study and shall submit final study update at the end of the study.
- Party A shall perform all trial related activities following ethical principles in strict adherence to ICH- GCP guidelines and Clinical Trial Act 2019.
- Part A shall ensure protocol & applicable regulatory guidelines compliance and adherence.
- Party A shall report all AE/SAEs to MGM-ECRHS within 24 hours. Moreover, the SAEs reported by other centers should also be reported from time to time with comments, if any action is required in the current study.
- Party A shall document any protocol deviation as appropriate and communicate any impacting subject safety to MGM-ECRHS.



- Party A shall also notify premature termination of study with reasons along with.
- Party A shall extend all the co-operation for monitoring the conduct of the study by MGM-ECRHS.

This agreement will last for 05 (five) years and can be renewed further on mutual agreement.

B. Obligations of Party B

- The ethics committee of Party B i.e. MGM-ECRHS is entrusted with the initial review of the proposed research proposals prior to initiation of the projects.
- A <u>50% discount in EC fees</u> shall be provided for each submitted protocol and other services related to EC (SAE, Amendment to protocol) which are paid.
- <u>As per current version of EC SOP, EC fees</u>
 - For routine review of a protocol Rs 75,000
 - > For expedited review of a protocol Rs 85,000
 - For Amendment to protocol Rs 30,000
 - SAE review fees Rs 30,000
- MGM-ECRHS shall also have a continuing responsibility of regular monitoring of the approved projects to foresee the compliance of the ethics during the period of the project in accordance with the regulatory guidelines wherever applicable.
- MGM-ECRHS members may perform on-site inspection of Party A "for cause" or for a routine audit.
- "For cause" monitoring will be performed, in any of the following conditions:
 - for high number of protocol violations,
 - Remarkable SAE reports,
 - High recruitment rate,
 - Non-compliance or suspicious conduct, and
 - Any other cause as decided by MGM-ECRHS member.

C. Term of Agreement

The term of this Agreement shall be for a period of 05 years commencing on the effective date 07 Feb 2022. However, this Agreement shall be reviewed annually by both parties if needed.

D. Confidentiality

• The parties here recognize and agree that due to the complex and competitive nature of the business, the confidentiality of information concerning both parties is of critical importance. Either party shall not, either during or after the term of this Agreement, disclose to any third



party any confidential information and all Information or information relative to the work or the business of either party without the written consent of either party.

- Party A agrees that it shall not during, or at any time after the termination of this Agreement, directly or indirectly disclose or use any information for any reason whatever, without the prior written consent of party B.
- Party B shall not disclose to any third party any information about new studies received from Party A.

E. Termination of Agreement

This Agreement shall be terminated by mutual agreement by giving sixty (60) days prior written notice by either party after the completion of any ongoing trials.
