As per direction of Hon'ble Vice Chancellor, Dr. Ashlesha Tawde (UBA Coordinator, Navi Mumbai Campus) attended the meeting as "Special invitee".

Dr. Shashank Dalvi, Hon'ble Vice Chancellor welcomed all the members and expressed his warm greetings to all. In his opening remarks to the members of the Academic Council, he briefed as follows:

- NAAC Grade Declaration 2nd cycle A⁺⁺, CGPA 3.55: He congratulated and appreciated the Management, University officials, Faculty, Non-teaching staff, Students (UG & PG) for their contribution in achieving "A⁺⁺" with CGPA-3.55 in the 2nd cycle accreditation of NAAC.
- Category I University: With NAAC "A⁺⁺" & CGPA-3.55, MGMIHS is upgraded to "Category-I" University and deemed to be under section "12-B" of the University

Grants Commission Act, 1956 and no inspections by the Commission shall be required for the same. With “Category-I” recognition, University may now start a new course / programme / department / school / centre in disciplines that form a part of its existing academic framework without approval of the UGC. University may open constituent units / off-campus centres within its geographical jurisdiction, without the approval of the UGC, provided it is able to arrange both recurring and non-recurring revenue sources and does not need any assistance for the same from the UGC or the Government. University may engage in academic collaborations with foreign educational institutions, as per the UGC (Promotion and Maintenance of Standards of Academic Collaboration between Indian and Foreign Educational Institutions) Regulations, 2016, without approval of the Commission with foreign institutions in top 500 of Times Higher Education World University Rankings or QS Rankings.

As per direction of Hon'ble Vice Chancellor, Dr. Shantanu Mallick (Faculty incharge, Fellowship in Pain Clinic) and Dr. Aarthika Sreenivasan [Faculty incharge, Fellowship in Clinical Neurophysiology - Nerve Conduction Study (NCS), Electromyography (EMG) and Evoked Potentials (EP)] attended the meeting as "Special invitee".

Dr. Shashank Dalvi, Hon'ble Vice Chancellor welcomed all the members and expressed his warm greetings to all. In his opening remarks to the members of the Academic Council, he briefed as follows:

1. In accordance with National Credit Framework and NEP guidelines, there is credit-based evaluation system in the programmes of Physiotherapy, Nursing and Biomedical Sciences. He suggested Dean/Director/Principal of constituent units to encourage more and more students to enrol under Digi locker and Academic Bank of Credits.

2. MGMIHS have signed a MOU with QS-ERA India Private Limited for QS I-Gauge rating of MGMIHS. The whole process will take nearly six to eight months. This is a step forward for applying for international accreditation/ranking.
3. MGMIHS have signed an agreement with M/s Elsevier Clinical Key Software for subscription of Online Resources-Clinical key & ClinicalKey student for one year. He further added that a demo of ClinicalKey Flex and CliniciilKey Students have been organised by Elsevier on 20th April, 2023 and 27th April, 2023 at Navi Mumbai and Aurangabad respectively. He advised Deans of both the campuses to propagate and motivate maximum number of students, interns, PG Students and faculties to use this particular software.

To make this possible we will need to conduct University exam/evaluation for sem VII & VIII. But as a special case we will be taking approval from the BOM to waive of the tuition fees and exam fees for 4th year till implementation of the revised curriculum and credit framework for UG programs (all admission in the AY 2020-21 till 2023-24).

For revision of the syllabus as per the Curricular and credit frame work reforms for 4-year UG program as per NEP 2020, a task force committee will be constituted at MGMIHS for all

existing CBCS programs running under constituent colleges of MGMIHS to be applicable from AY 24-25 where we need include tuition fees for the 4th year.
