Resolution 1: Controller of Examinations presented the UG & PG examinations schedule to all the members as per NMC and academic calendars prepared by MGM Medical Colleges Navi Mumbai & Aurangabad which were approved in Board of Studies and Academic Council.

Hon'ble Vice Chancellor presided over the meeting and welcomed all the members. He briefed them about the purpose of the meeting, Dr. Parineeta Samant, Controller of Examinations conducted the meeting.

1 To confirm the minutes of meeting held on 18.11.2022 (BOE 05/2022)

Resolution 1:

It was unanimously resolved to approve the minutes of the previous BOE 05/2022 dated 18.11.2022

Item 2: To review the dates examiners appointed, exam related compliance for PG examinations scheduled in various PG departments for increase in seats Aurangabad & Navi Mumbai

Resolution 2:

Hon'ble Vice Chancellor briefed all the member about the purpose of the meeting. In his opening remarks.

He advised Dean faculties to verify the eligibility criteria of all examiners appointed for MD & MS examinations.

He also mentioned changes of NMC in passing criteria and practical examination formats must be known to all the examiners. He suggested that both the Dean's (Navi Mumbai and Aurangabad) should conduct one meeting with the conveners and appraise them about theory and practical examination formats.

Controller of Examinations presented campuswise list of departments scheduled for NMC inspections for increase in seat of MD /MS programme and also the departments for which only practical examination is scheduled but no NMC inspection.

Controller of Examinations appraised all the members about updated MD / MS curriculum (CBME) and practical evaluation format of all subjects as per NMC along with reference of academic council approval. Dean Dr. G. S. Narsheety stated that all updated syllabus and practical formats will be required for forthcoming MD /MS inspection. Controller of Examination specified that these updated syllabus should also be available on MGMIHS website.

In response to this Dr. Rajesh Goel, Registrar requested all the Heads of the department to visit academic section of MGMIHS and get the latest approved curriculum on upload MGMIHS website.

Dr. G. S. Narshetty proposed to start on screen evaluation of MD/MS answer booklet. After examining the merits and demerits of the process it is decided to start onscreen evaluation for MD/MS theory paper from June 2023 onwards. Before implementing this on mass scale it; is necessary to work as pilot project in same subjects at both the campuses. Hon'ble Vice Chancellor & Pro-Vice Chancellor also suggested to keep plan B ready in case of any technical problem in the subjects in which digital evaluation will be carried out.

Hon'ble Vice Chancellor inform expressed the idea to establish new CAP centre at Navi Mumbai campus under MGM Medical College, Navi Mumbai. Also appoint one senior faculty as CAP Director & one dedicated CAP Incharge for this purpose.

Item 3: Information about mercy attempt rule by NMC for 1st M.B.B.S 2019-20 batch

Resolution 3:

Controller of Examinations Presented the result data of I MBBS students, academic year 2019-20 from Navi Mumbai & Aurangabad. NMC has issued a circular of mercy attempt to MBBS student of 1st professional, In context to that and clarified that all students of 2019-20 batch oif MBBS first professional are passed and there is no backlog.

It was unanimously resolved to inform the mercy attempt rule by NMC for 1st M.B.B.S 2019-20 batch, in undertaking taken from students and parents. Also all rules with the MBBS programme should be part of foundation course.

Item 4: Review of Number of fail students of 1st M.B.B.S Batch 2020-21 & 2021-2022

Present status of MBBS first professional 2020-21 and 2021-22 batches was also presented by Catroller of examinations.

All first professional students of 2020-21 batch at Aurangabad are passed where as there is one student from Navi Mumbai campus where revaluation is remaining.

All students First professional MBBS 2021-22 batch from Aurnagabad have passed in April 2023 examination where as from Navi Mumbai campus 3 students have failed in 2nd attempt.

It is resolved to take undertaking from MBBS student at the time of admission about the attempt guidelines.

Item 3: Presentation of IVS (Internal Vigilance Squad) report

Resolution 3:

It is resolved to approve and accept IVS squad reports submitted by Navi Mumbai & Aurangabad campus was placed for the Board of Examination members.

Pro-Vice Chancellor suggested to upgrade all jammers 4G to 5G at both campuses.

Item 4: To keep additional days for theory paper online evaluation during practical examination for MD and MS programme

Background of Resolution:

It is observed that examiners do not get adequate time for correction of theory paper on the day of practical examinations. Hence it is proposed to have additional one day prior to the day of practical examination for CAP.

Resolution 4:

It is resolved to assign additional day for CAP for all the examiners and conduct onscreen evaluation of theory paper by same set of examiners (Internal + External) prior to commencement of practical examination. The theory papers from Navi Mumbai and Aurangabad will be scanned together and will be assigned randomly to Internal and External examiners for assessment.

Item 5: Proposing revision of remuneration for examiners as per MUHS only Medical programmes

Background of Resolution:

MUHS has revised the remuneration for admissible manpower from 25th April 2023. As per resolution of BOM 38 dated 28-11-2014, MGMIHS accept and implement the rates of admissible manpower whenever MUHS revises after talking approval through BOM.

Resolution 5:

It is unanimously resolved to accept and implement revised rates of remuneration as per MUHS notification date: 25.04.2023 as per BOM 38 resolution dated 28-11-2014. Considering the additional economic burden, hike in examination fees of all the programmes is essential. (Annexure-2)

Item 6: Proposal for examination fees for PhD thesis Defense

Background of resolution:

For PhD Thesis defense MGMIHS invites two referees (One within state and another from outside state). The traveling and dearness allowance along with remuneration amounts to approximately 25000 to 30000 per candidate. Presently there is no fees charged to candidate for submitting thesis for evaluation.

Resolution 6:

It is resolved to introduce PhD thesis defense fees of Rs.25000/- per student from Academic Year 2023-2024.

Item 7: Proposing revision of examination fees for MBBS, MD/MS & DM/MCh programme & other University fees.

With reference to Item no 5 and its resolution, the economic burden is expected to rise by 40 to 45% hence it was proposed to hike the examination fees for Medical programmes

Resolution 7:

It is resolved to take decision of revision of examination fees for all programmes only after review of student wise exam expenditure of all programme. This item will be taken in forthcoming Board of Examinations and MOM of the same will be referred to Board of Management.

Item 8: Proposal for applying late fees for examinations

It is observed that invariably examination process timeline (session Calendar filling examination form, payment of examination fees) is not followed by students. Exam section receives multiple request beyond the defined time line, Due to which examination related activities like generation admit cards, barcodes, printing of question papers, are delayed, so in order to bring discipline, it is proposed to introduce late fees for examination form filling and payment of Examination fees beyond the notified date in the session calendar.

Resolution 8:
