

The surgeries were performed under the guidance of MGM deputy dean Dr Pravin Suryawanshi by Dr Narayan Sanap, Dr Ravi Mohanka, Dr Ashok Mohite, Dr Anand Nikalje, Kidneys of a braindead person were transplanted on a 31year-old patient from the city and liver was transplanted into a 66-year-old patient from Mumbai

Dr Jambure, Dr Manjusha Bhume, Vinavak DrNikam, Manoj Gadekar Dhobale. Javesh and President of the Zonal Transplant Coordination (ZTCC) Committee Sudhir Kulkarni was present. This agreement (the "Agreement") is executed at Aurangabadon this 9th day of July, 2022,

BY AND BETWEEN:

SIR HN HOSPITAL TRUST, a public charitable trust, registered under The Maharashtra Public Trusts Act, 1950, having its office at Prarthana Samaj, Raja Rammohan Roy Road, Girgaon, Mumbai- 400 004, India (hereinafter referred to as "HNH" which expression shall, unless repugnant to the context or meaning thereof, mean and include the trustee or trustees for the time being, survivors or survivor of them and the heirs, executors and administrators of the last survivor.

AND

MGM MEDICAL COLLEGE AND HOSPITAL, AURANGABAD a private trust Hospital, registered under The Maharashtra Public Trusts Act, 1950, having its office at N-6, CIDCO, Aurangabad- 431 003 (hereinafter referred to as "MGMMCHA", which expression shall unless repugnant to the context or meaning thereof, mean and include trustee or trustees for the time being, survivor or survivors of them and their heirs, executors and administrators of the last survivor.

HNH and **MGMMCHA** are hereinafter individually referred to as a "Party" and collectively as the "Parties".

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND PROMISES HEREIN CONTAINED, IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. DEFINITIONS:

1.1 In the Agreement (including the recitals), unless the context otherwise requires, the following expressions shall have the following meanings:

"Agreement" shall mean this agreement together with its annexures, as may be supplemented, amended or otherwise modified from time to time in accordance with the terms contained herein.

"Applicable Laws" means all laws in force and effect as of the date of execution of the Agreement and which may be promulgated or brought into force and effect hereinafter, in India, including any revisions, amendments or re-enactments, including without limitation, rules, regulations and notifications made there-under and judgments, decrees, injunctions, writs, orders and notifications issued by any court of record or competent authority, as may be in force and effect during the subsistence of the Agreement.

"Applicable Permits" shall mean any license, authorization, certification, filing, recording, permit or other approval of any of the governmental authorities, including, without limitation, any operating permit and any agreement, consent or approval from or with any other person that is required under the Applicable Laws for purpose of the Agreement.

"Best Medical Practice" means a degree of quality healthcare, practices, methods, interventions, procedures or techniques based on high-quality evidence in order to obtain improved patient and health outcomes.

"Claims" shall have the meaning assigned in clause 7.1.

"Confidential Information" shall have the meaning assigned in clause 10.1.

"Consumables" shall mean the medical/ pharmaceutical consumables and devices, including medications, injections, drugs, implants, surgical disposables (in necessary numbers), medical gases, all types of blood products and such other items as may be required by HNH Professionals to perform the Services.

"Consent" shall mean the written consents required from the Patient/s as per the Applicable Laws and established medical protocols including the medical protocols, if any, of MGMMCHA and such other consents as may be advised or required by HNH in relation to the Services.

"Effective Date" shall mean the date of execution of the Agreement by all the parties.

"Go-Live Date" shall have the meaning assigned in clause 2.2.

"MGMMCHA Personnel" shall mean the persons engaged by MGMMCHA to support the Services, including the doctors (residents or otherwise) in surgical, anesthesia, critical care and other junior







supporting para-clinical /paramedical staff; nurses, OT technicians, technical and non-clinical personnel.

"Gross Medical Negligence" shall mean the heightened neglect of the use of ordinary care or skill towards a Patient to whom the medical practitioner owes the duty of observing ordinary care and skill, by which neglect such Patient has suffered injury to his person or property.

"HNH Professionals" shall mean and include and refer to Dr. Ravi Mohanka and other medical practitioners engaged by HNH to provide the Services as provided in Annexure 3.

"Medical Infrastructure" shall mean the necessary infrastructure and facility at MGMMCHA including but not limited to state of the art medical equipment and infrastructure, pharmacy, an OPD for organ transplant clinic, dedicated organ transplant intensive care unit (ICU), well equipped operation theatre (OT) with High Efficiency Particulate Air (HEPA) filters, positive pressure ventilation in all individual rooms/cubicles, investigative and diagnostic facilities, imaging, blood bank (having all types of blood products), ambulance and such other infrastructure as may be required by HNH/HNH Professionals from time to time to perform the Services.

"Medical Legal Liability" shall mean and include any liability/ claim arising out of bodily injury and/or death of a Patients caused by or alleged to be caused by error, omission, negligence or deficiency in the medical services rendered at the Premises.

"Package Cost" shall mean the cost charged by MGMMCHA to the Patients for the Services, in consultation with HNH.

"Patients" shall refer to the patients registered/enrolled by MGMMCHA to avail the Services.

"Premises" shall mean the premises established and maintained by MGMMCHA located at N-6, CIDCO, Aurangabad- 431 003.

"Pre-operative care" shall mean the actions to be carried out before availing the Services, including but not limited to recording history and physical examination to be performed, recording concurrent illnesses, recent infections or exposures, current complications of underlying disease, immunizations, allergies, current medications, evidence of acute infection, respiratory status, cardiac status, abdominal girth, liver and spleen size, ascites, clubbing, oedema, signs of encephalopathy.

"Post- Operative Care at the Hospital" shall mean the actions to be carried out after the liver transplant, including but not limited to (i) initial close monitoring and care; (ii) checking for any signs of bleeding, infection or other complications; (iii) analysis of the liver function at regular intervals with frequent blood tests (iv) recovery of the living donor (iv) detailed instructions provided in discharge summary at the time of discharge.

"Post- Operative Care after Discharge" shall mean and include the medications, prescriptions with tests such as blood tests, ultrasounds and chest x-rays, etc. to be carried out after Patient's discharge from the hospital in order to monitor the liver function regularly, measures to be taken to prevent the onset of infections, diet and nutrition, activity and exercise, engaging with physiotherapists and conducting counselling sessions.







"Services" shall mean the services enumerated in Annexure 1, to be provided by HNH Professionals at the Premises in accordance with terms and conditions contained in the Agreement.

"Service Fee" shall mean the service fee as detailed in Annexure 2, to be paid by MGMMCHA to HNH in accordance with clause 6.

"Term" shall have the meaning assigned clause 13.1.

"Utilities" shall mean the utilities such as electricity, laundry, CSSD and any other utility item that is required and incidental to provision of Services. The level, quality and durations of such Utilities shall be mutually agreed between the Parties from time to time.

1.2 PRINCIPLES OF INTERPRETATION:

The following rules of interpretation shall be followed while interpreting the Agreement:

- (i) The descriptive headings of clauses are inserted solely for convenience of reference and are not intended as complete or accurate descriptions of content thereof and shall not be used to interpret the provisions of the Agreement.
- (ii) The use of words in the singular or plural, or with a particular gender, shall not limit the scope or exclude the application of any provision of the Agreement to any Person or Persons or circumstances except as the context otherwise permits.
- (iii) The terms "hereof", "herein", "hereto", "hereunder" or similar expressions used in the Agreement mean and refer to the Agreement and not to any particular clause of the Agreement. The term 'clause' means and refers to the clause of the Agreement so specified.
- (iv) The Annexures annexed to the Agreement, forms an integral part of the Agreement and will be in full force and effect as though they were expressly set out in the body of the Agreement.
- (v) Reference to any legislation or law or to any provision thereof shall include references to any such law as it may, after the date hereof, from time to time, be amended, supplemented or reenacted, and any reference to a statutory provision shall include any subordinate legislation made from time to time under that provision.
- (vi) References to the word "include" or "including" shall be construed without limitation.

2. CONDITIONS PRECEDENT:

- 2.1 The Agreement shall be enforceable from the date on which the following conditions are met and fulfilled by MGMMCHA:
 - (i) MGMMCHA has the Medical Infrastructure and Utilities;
 - (ii) MGMMCHA has the Applicable Permits;
 - (iii) MGMMCHA has customary and adequate insurance coverage against any Medical Legal Liability.
- 2.2 Subject to clause 2.1, HNH shall provide the Services from 9th July 22or such other date as mutually agreed between the Parties ("Go-Live Date").

3. OBLIGATIONS OF MGMMCHA:

- 3.1 **MGMMCHA** shall, at all times during the Term, procure, provide and maintain, at its sole cost and expense, the Medical Infrastructure and Utilities in good operating condition and to the satisfaction of HNH/HNH Professionals;
- 3.2 **MGMMCHA** shall promptly provide any additional medical infrastructure, equipment, facility or other item required by HNH Professionals for providing the Services, as may be mutually agreed between the Parties from time to time.
- 3.3 MGMMCHA shall carry out the Pre-Operative Care in accordance with Applicable Laws and Best Medical Practice and provide details thereof to HNH Professionals within stipulated timelines and carry out such other activity in relation thereto as may be advised by HNH Professionals.
- 3.4 MGMMCHA shall ensure timely admission of the Patient/s for availing the Services at all times during the Term in accordance with Applicable Laws and instructions of HNH Professionals from time to time.
- 3.5 **MGMMCHA** shall ensure that the Patient is fully informed of the procedure, risks, complications and adversities that may arise in course of the Services and thereafter and obtain the Consents in a timely manner.
- 3.6 **MGMMCHA** shall ensure seamless arrangement of urgent blood tests and availability of Consumables at all times in course of the surgery/Services.
- 3.7 MGMMCHA shall carry out Post-Operative Care in Hospital and Post-Operative Care after Discharge in accordance with Best Medical Practice and instructions from HNH Professionals in relation to the same from time to time. In cases where HNH Professionals provide Post-Operative Care in Hospital, the Fees payable shall be as detailed in Annexure 2.
- 3.8 **MGMMCHA** shall ensure periodic review of medical protocols and obligations set forth in this clause 3.
- 3.9 MGMMCHA shall be solely responsible for preparing and maintaining the records and case sheets of Patients and shall provide the same promptly to HNH on real time basis with entire records to be shared within 48 hours of discharge or death and MGMMCHA shall also follow any reasonable instructions as may be given by HNH in this regard. Such records can be uploaded onto a common portal, which will be accessible to both Parties at all times, and or stored in Medical Records Departments of both the Parties and preserved for 10 (Ten) years or in accordance with the Applicable Laws. In case any complaint/petition is filed before any authority, judicial or quasijudicial forum the records and case sheets mentioned in this para will be retained for a period of five years after the Order/Award of such authority/forum attains finality. The HNH Professionals will not be operating patients unless the records of previous patients has been received.
- 3.10 MGMMCHA shall, as and when requested by HNH, provide full access to HNH or its representatives to inspect such records and/or take copies of the same during the Term and anytime thereafter. It is clarified that HNH Professionals shall be responsible for preparing only such records which are appropriate to the role like the consultation notes, prescription and operation theater notes.

- 3.11 MGMMCHA shall, at all times during the Term, purchase, maintain and manage the Consumables. The same shall be of such quality/make and in such quantity as may be prescribed by HNH Professionals from time to time. HNH shall not be responsible and nor liable for any issues related to quality or quantity of the Consumables made available for performing the Services. However, in case HNH Professional uses any drugs/consumables (which they carry as a backup) of their own because of non-availability or unsatisfactory quality or brand, the same shall be billed to MGMMCHA by HNH at MRP rates in accordance with clause 6.3.
- 3.12 MGMMCHA shall, at all times during the Term, ensure that HNH Professionals have free and uninterrupted access to the Premises for providing the Services and the facilities incidental to the provision of Services;
- 3.13 MGMMCHA shall be solely liable for its obligations under Applicable Laws towards MGMMCHA Personnel. The expenses, salary/wages and statutory obligations related to MGMMCHA Personnel shall be borne by MGMMCHA. MGMMCHA Personnel shall continue to be the employees/consultants/staff of MGMMCHA, and nothing contained in the Agreement shall create any obligation on HNH in relation to MGMMCHA Personnel.
- 3.14 MGMMCHA shall bear all costs and expenses in relation to travel of HNH Professionals to MGMMCHA and back to Mumbai along-with lodging and boarding (in a decent hotel or rented accommodation in a good locality having proximity to MGMMCHA or furnished accommodation in the MGMMCHA campus and shall meet the HNH standards) including food and local hospitality during the period of stay of HNH Professionals for provision of Services. Such arrangements shall be in coordination with MGMMCHA. The same can be organized by HNH and shall be reimbursed by MGMMCHA to HNH within 15 (fifteen) days from the receipt of invoice with supporting documents as per clause 6.3.


4. OBLIGATIONS OF HNH/ HNH PROFESSIONALS:

- 4.1 HNH shall, from the Go-Live Date and subject to conditions set forth in clause 2.1, make available HNH Professionals to provide the Services at the Premises in accordance with Applicable Laws, terms contained in the Agreement and Best Medical Practice at such times as may be mutually agreed between the Parties.
- 4.2 HNH may, at the sole cost and expense of MGMMCHA, offer regular training for updation of skills and expertise of MGMMCHA Personnel periodically at Sir H. N. Reliance Foundation Hospital and Research Centre under Dr. Ravi Mohanka on honorary basis. The number of MGMMCHA Personnel to be trained, frequency, duration, time and nature of training shall be mutually decided by the Parties before each training.

5. JOINT OBLIGATIONS OF PARTIES:

5.1 It is agreed between the Parties that Dr. Ravi Mohanka shall be responsible and liable for providing the medical and other Services under the Agreement with necessary assistance from HNH







- Professionals. MGMMCHA shall make available, at all times during the Term, MGMMCHA Personnel as may be required by HNH Professionals from time to time.-
- 5.2 MGMMCHA, MGMMCHA Personnel and HNH Professionals shall strictly comply with the Applicable Laws including but not restricted to The Transplantation of Human Organs Act, 1994 and all statutory rules and regulations framed thereunder from time to time.

6. **SERVICE FEE**:

- 6.1 MGMMCHA shall pay the Service Fee, along with all applicable taxes, by way of direct bank transfer / demand draft drawn in the name of 'Sir H N Hospital Trust' and payable within 15 (fifteen) days from the receipt by MGMMCHA of debit note/invoice from HNH for the same. Any revision in the Service Fee shall be mutually agreed between the Parties in writing.
- 6.2 **MGMMCHA** shall pay the Service Fee irrespective of its receipts of the Package Cost from the Patients/insurance/TPA/corporate. Next scheduled Services shall be performed only after the receipt of Service Fee for the earlier debit note/invoice.
- 6.3 HNH shall raise debit note/invoice towards consumables, if any, provided by HNH and travel, accommodation and other expenses, if any, incurred by HNH for providing the Services and MGMMCHA shall reimburse the same within 15 (fifteen) days from date of receipt of debit note/invoice towards the same.
- 6.4 If there is any delay by **MGMMCHA** in paying the aforementioned Service Fee and or reimbursement of consumables and or reimbursement of travel and accommodation, **MGMMCHA** shall be liable to pay interest at the rate of 18% per annum to HNH on the outstanding amount for the delayed period (i.e. from the due date till the date of actual payment).
- 6.5 In case MGMMCHA deducts tax deductible at source (TDS), MGMMCHA shall provide a TDS certificate to HNH before expiry of the financial year to enable HNH to file its returns in a timely manner.
- 6.6 In the event MGMMCHA raises any dispute with respect to any amount payable under this clause 6, it shall, at the first instance, pay to HNH the entire amount and such dispute shall be resolved in accordance with clause 14.1. HNH shall, where it is determined by the court having final jurisdiction, that any amount under dispute is required to be paid to MGMMCHA, pay the same within 7 (seven) days from the date of such determination.
- 6.7 MGMMCHA shall be solely responsible for billing and recovery of Package Cost and any additional charges due from the Patient/s in its own name and on its own account. It undertakes to prepare and keep financial statements and the books of accounts of the Services in accordance with applicable accounting policies and shall provide a statement of the same to HNH in a particular month on or before 15th of the next month. HNH shall have the right to audit the books, financial statements and bills related to the Services during reasonable business hours with reasonable prior written notice and MGMMCHA shall extend its full co-operation to HNH in this regard during and after the termination/ expiry of the Agreement.

7. INDEMNIFICATION:

The guiding principle in this Clause will be that each party will be responsible for its acts as per the allocation of work in this Agreement and in case of doubts/allegations/complaints filed before any authority, judicial or quasi-judicial forum, each party will work in coordination with each other to ensure a harmonious, common response to the said doubts/allegations/complaints.

- 7.1 MGMMCHA shall indemnify and hold harmless HNH, its trustees, officers, employees, consultants, agents, representatives and HNH Professionals ("Indemnified Parties") from and against any and all suits, sanctions, legal proceedings, claims, damages, penalties, liabilities, demands and losses ("Claims") incurred or sustained by the Indemnified Parties as a result of or relating to: (i) breach by MGMMCHA of any of its obligations, representations and warranties; (iii) non-compliance by MGMMCHA with any Applicable Laws; or (iv) any act of willful misconduct or Gross Medical Negligence by MGMMCHA Personnel.
- 7.2 Notwithstanding anything to the contrary set out in the Agreement, HNH and/or HNH Professionals shall not be liable or responsible with respect to any claim of Medical Legal Liability (other than the Services rendered by HNH Professionals under the Agreement). Such Medical Legal Liability shall be the sole responsibility of **MGMMCHA** and **MGMMCHA** shall keep HNH and/or HNH Professionals indemnified in this regard.

Each HNH Professional shall procure independently professional indemnity insurance coverage against Medical Legal Liability.

Medical Legal Liability to the extent arising directly from the Services rendered by HNH Professionals under the Agreement shall be joint and several responsibilities Dr. Ravi Mohanka and HNH Professionals (hereinafter referred to as the "Indemnifying Parties") and the Indemnified Parties shall keep HNH indemnified in this regard.

- 7.3 HNH Professionals (and not HNH) shall indemnify MGMMCHA, its officers, employees and agents ("Indemnified Parties") from and against any Claims incurred of sustained by Indemnified Parties directly as a result of or relating to (i) breach of representations and warranties furnished by HNH or HNH Professionals; (ii) non- compliance by HNH Professionals with any applicable laws; or (iii) any act of willful misconduct or Gross Medical Negligence solely attributable to HNH Professionals.
- 7.4 It is hereby clarified that HNH Professionals shall not be liable under the Agreement for any Claim incurred or sustained by MGMMCHA where HNH Professionals have been adjudged by a competent judicial and/or quasi-judicial authority of having confirmed to standard to care prevalent in the medical field and/or where such claim is on account of or attributable to non-availability of adequate and appropriate Medical Infrastructure, Consumables, Utilities and facilities required for smooth provision of Services and/or where MGMMCHA has failed to fulfil its obligations under the Agreement and/or where such claim has arisen due to or is attributable to the acts or omissions of MGMMCHA or MGMMCHA Personnel.
- 7.5 In any event MGMMCHA and HNH and their respective trustees, representatives, staff, employees, directors, agents and HNH Professionals shall not be liable for any indirect or consequential damages of whatsoever nature that may arise in connection with the Agreement.

8. EXCLUSIVITY AND NON-POACHING:

- 8.1 **MGMMCHA** shall not, during the Term, enter into any arrangement for provision of services similar to the Services with any third party during the duration of the contract.
- 8.2 It is understood between the Parties that, during the Term neither Party shall, without prior written consent for the other Party, entice, solicit, recruit or hire any personnel of the other Party that is an employee of / is retained by the other Party.
- 8.3 During the Term, neither Party shall directly or indirectly, either solely or jointly, engage in any unethical activity which might have any negative effect on HNH's or MGMMCHA's goodwill and brand.
- 8.4 Parties agree that the restrictions contained in this clause are reasonable and necessary in the interest of the Parties and for preserving the mutually beneficial relationship.

9. USE OF BRAND NAME/ MARKS AND ADVERTISEMENT:

- 9.1 From the Go-Live Date and at all times during the Term, **MGMMCHA** shall display signage, mutually agreed by the Parties, prominently at the Premises in a manner agreed between the Parties.
- 9.2 Subject to the Parties performing their respective obligations under the Agreement and in any case only during the Term, each Party permits the other Party to identify and publicize/ advertise that the Services at the MGMMCHA are provided by HNH Professionals, provided however, that all such advertisements, press releases, announcements, publicity materials etc. shall be mutually approved by the Parties and shall not be released without the prior written consent of the Parties.
- 9.3 Each Party shall have the right, during the Term, to use the brand name of the other, free of cost, for undertaking advertising and marketing activities with respect to the Services with prior written consent from the other Party.
- 9.4 Notwithstanding anything contained in the Agreement elsewhere, it is hereby clarified that the intellectual property marks/ brand names of each Party shall at all times remain their exclusive property and Parties warrants not to, during the Agreement or any time thereafter, claim any interest, right or privilege whatsoever, including but not limited to any intellectual property right, in the brand name of the other Party.
- 9.5 The Parties agree and confirm that the co-branded name, if any, developed by them during the existence of the Agreement shall be jointly owned by both the Parties and neither Party shall claim any personal rights or derive any personal privileges from it, other than the Agreement warrants for, without the written approval from the other Party, during the tenure of the Agreement. The Parties further agree and confirm that subsequent to the tenure of the Agreement, the Parties shall discard usage of the above co-branded name at any of its communication /advertisement/or any such other means without the written permission from other Party. However, the Parties shall be free to use their respective brand name separately.







10 CONFIDENTIALITY:

- 10.1 Parties shall keep strictly confidential the existence and terms of the Agreement and any and all confidential, sensitive or proprietary information obtained by either Party during the term, in relation to the Agreement ("Confidential Information"), including, without limitation, Patient data, financial and operational information relating to either Party and shall not divulge the same to any person or entity other than officers and employees strictly on a 'need to know' basis for performance of its obligations hereunder, unless required by Applicable Laws.
- 10.2 The provisions of this clause shall not prevent either Party from disclosing any information where it can demonstrate that such information:-
 - (i) was in its possession (with full right to disclose) prior to receiving it from the disclosing Party;
 - (ii) is or subsequently comes into the public domain other than by breach of its obligations hereunder;
 - (iii) is independently developed by the receiving Party;
 - (iv) was received from a third party who was free to divulge it;
 - (v) was required to be disclosed under an order or instruction from a court or tribunal or other authority of competent jurisdiction, provided that the receiving Party, to the extent reasonably practicable, gives the disclosing Party reasonable written notice to allow the disclosing Party to seek a protective order or other appropriate remedy;
 - (vi) if required to seek professional advice from the professional advisors (provided such advisors are subject to confidentiality obligations as contained herein); or
 - (vii) Disclosure obligation to the lenders in connection with availing credit facilities (provided such lenders are subject to confidentiality obligations).
- 10.3 The confidentiality provisions contained herein shall survive the termination or expiry of the Agreement.

11. REPRESENTATION AND WARRANTIES:

- 11.1 Each Party hereby represents and warrants that:
 - it is duly incorporated and /or registered, validly existing and in good standing under the Applicable Laws and has all requisite power and authority to enter into and perform its obligations under the Agreement;
 - (ii) the Agreement shall constitute its legal, valid and binding obligations, enforceable against it in accordance with its terms;

- (iii) execution of the Agreement or performance of its obligations hereunder does not contravene (a) any law to which it is subject to; (b) any agreement to which this is a party; or (c) its constitutional documents, i.e. the memorandum of association and articles of association; and
- (iv) no legal proceeding or other proceedings of governmental investigations is pending or is threatened against it which would affect, in any manner, its ability to enter into or perform its obligations under the Agreement.

11.2 In addition to the above, MGMMCHA hereby represents and warrants that:

- it is in compliance with all Applicable Laws and has obtained/will obtain all required registrations, approvals and consents under Applicable Laws to set up and to operate MGMMCHA and provision of Services;
- (ii) MGMMCHA and its infrastructure (including Medical Infrastructure) is free from any restriction, which may, in any manner, affect HNH's ability to provide Services at the MGMMCHA.
- (iii) the Medical Infrastructure provided in the **MGMMCHA** is state of the art, in good working condition and adequate to allow HNH Professionals to provide Services in the most efficient manner.
- (iv) MGMMCHA Personnel shall have the adequate qualifications and experience.

12. FORCE MAJEURE:

Neither Party shall be in default if a failure to perform any obligation (other than an obligation to make monetary payments) hereunder is caused solely due to supervening conditions beyond that Party's reasonable control including acts of God, natural calamity, flood, storm, fire, war, civil commotion, epidemic, pandemic, strikes and labor disputes affecting a national category of workers, acts of terrorism and governmental or public authorities demands or requirements (including change in Applicable Laws). The Parties agree that if such an event continues for a period of 1 (one) month, either Party can terminate the Agreement by giving written notice.

13. TERM AND TERMINATION:

- 13.1 The Agreement shall be effective for a period for 3 (three) years from the Effective Date to 9th July 2022 ("Term"); unless terminated earlier pursuant to the provisions of the Agreement. The Parties may mutually agree to extend the Term for a further period on mutually acceptable terms and conditions.
- 13.2 Either Party can terminate the Agreement by giving 3 month's written notice without assigning any reason thereof.
- 13.3 In the event of either Party committing any breach of the terms and conditions of the Agreement, the other Party may serve a notice in writing on the breaching Party committing the breach requiring that such breach be remedied within the time stipulated in that notice. If the breach is

not remedied within the stipulated period, the other Party shall be entitled to terminate the Agreement on the expiry of such stipulated period.

13.4 Effects of Termination or Expiry of the Term

- (i) Parties shall be relieved and discharged from all liabilities, obligations or claims under the Agreement, except for such rights, liabilities and obligations of the Parties which have accrued under the Agreement prior to the termination/expiry or which survive the termination/expiry (including ongoing treatment of any Patient at the Premises). It shall be the responsibility of HNH Professional's, subject to MGMMCHA providing access at the Premises without any interruption whatsoever, continue with the treatment of existing Patients till their discharge and shall not cease with the expiry or termination of the Agreement, it is expressly clarified that MGMMCHA shall continue to fulfill all its obligations including but not limited to incurring all costs in relation thereto.
- (ii) MGMMCHA shall, within 10 (ten) days from the date of the termination or expiry of the Agreement, prepare final financial statements and books of accounts with respect to the total revenue generated on account of the Services provided by HNH Professionals and compute the accrued unpaid HNH's Service Fee and any other amounts that may be due and payable under the Agreement as on the date of the termination or expiry of the Agreement, and submit such accounts to HNH. The payments to HNH shall be based as per Annexure 2.
- (iii) Within 15 (fifteen) days from the expiration or termination of the Agreement, MGMMCHA shall pay to HNH:
- a. all amounts (including Service Fees, reimbursements (if any) of HNH Professionals, etc.) due and payable till the date of termination; and
- b. all amounts (including Service Fees, reimbursements (if any) of HNH Professionals, etc.) due and payable with respect to the treatment provided to existing Patients after termination or expiry of the Agreement.
- (iv) The Parties shall cease to use the co-branded name, if any. Each Party shall cease to display the name of the other Party anywhere and shall cease to use/have any rights to the intellectual property of the other Party, if any, conferred on it as per or pursuant to the Agreement and shall also forthwith cease to use its stationery, letter heads, name boards, promotional materials etc. or in any way directly or indirectly make any representations to the effect that it is associated with the other Party.
- (v) Parties shall immediately cease using the Confidential Information of the other Party and shall, in accordance with the instructions received from the other Party dispose of the Confidential Information.







14. GOVERNING LAW AND DISPUTE RESOLUTION:

- 14.1 Any dispute, controversy or disagreement arising hereunder or in connection with the Agreement ("Dispute") which is not settled by the Parties by mutual discussions within 15 (fifteen) days of a request by either Party for settlement, or within a mutually extended period, such Dispute may be referred to arbitration by 3 (three) arbitrators, 1 (one) arbitrator to be appointed by each Party and the 2 (two) arbitrators so appointed shall appoint the third arbitrator, in accordance with the provisions of the Arbitration and Conciliation Act, 1996, or any statutory amendment or re-enactment thereof for the time being in force. The award passed by the arbitral tribunal consisting of the aforesaid 3 (three) arbitrators shall be final and binding on the Parties. The venue of Arbitration shall be Mumbai and the arbitration proceedings shall be in English language.
- 14.2 The Agreement shall be governed by and construed in accordance with laws of India.
- 14.3 Parties unconditionally and irrevocably agree to submit to the exclusive jurisdiction of the competent courts of Mumbai to the extent reference to courts is permitted under the Arbitration and Conciliation Act, 1996.

15. NOTICE:

Any notice or other communication that may be given by one Party to the other shall always be in writing and shall be served either by (i) hand delivery duly acknowledged; or (ii) sent by registered post with acknowledgment due; or (iii) by facsimile at the respective addresses set out herein below or at such other address as may be subsequently communicated by one Party to the other in writing as set out herein. If the notice is sent by facsimile, the said notice shall also be sent by registered post acknowledgment due.

16. GENERAL PROVISIONS:

- 16.1 Each of the Parties shall nominate one of its representatives as a coordinator of the respective Party, for the day-to-day administrative co-ordination between HNH and **MGMMCHA** arising out of the Agreement.
- 16.2 Neither Party shall assign any of its rights or obligations under the Agreement to any third Party without prior written consent from the other Party.
- 16.3 Any modification to the Agreement (including modification with respect to any dates or timelines specified herein) or any waiver of any right, power or privilege under the Agreement, to be effective, must be in writing and signed by both Parties.
- 16.4 If any provision of the Agreement is determined to be invalid or unenforceable under Applicable Laws, all other provisions of the Agreement shall continue in full force and affect unless the invalid or unenforceable provision comprises an integral or inseparable part of the Agreement. Provided, however, that if such severability materially changes the economic benefits of the Agreement to any Party, the Parties shall endeavor to negotiate adjustment in the provisions of the Agreement in good faith.
- 16.5 Nothing in the Agreement or its performance by the Parties shall be taken as creating a relationship of principal-agent, employer-employee, partnership or joint venture between the Parties and neither Party will have the right to bind the other through any of its actions. The Parties hereby agree that the relationship between them is of principal to principal basis.
- 16.6 Save as expressly provided in the Agreement or otherwise agreed in writing, neither Party shall enter into or have any authority to enter into any agreement and contract or make any representations or warranties or pledge the credit of or otherwise create any obligations expressed or implied on behalf of the other and each party undertakes not to do so.
- 16.7 The Parties agree that the Agreement (along with its Annexure) is the complete and exclusive statement of the agreement between the Parties which supersedes all proposals or prior agreements, oral and written, and all other communications between the Parties relating to the subject matter of the Agreement.











16.8 Such clauses shall survive the termination or expiry of the Agreement which by its very nature should survive the expiry and termination of the Agreement.
