WHERE AS MGM Hospital & Research Centre has approached the Blood Bank for considering credit tie- up facility for Supply of Blood & Blood Products as a Mother Blood Bank to the Blood Storage

Facility at the Hospital for their Patients undergoing Surgical / Nonsurgical Procedures at MGM HOSPITAL & RESEARCH CENTRE, Vashi, Navi Mumbai.

1. It is hereby agreed by and between MGM HOSPITAL & RESEARCH CENTRE and Sadguru Charitable Blood Bank, Koparkhairane.

i. MGM HOSPITAL & RESEARCH CENTER could avail of the credit tie-up facility for Supply of Blood & Blood Products to the Hospital for their Patients undergoing Surgical/ Nonsurgical Procedures at MGM HOSPITAL & RESEARCH CENTER .

ii. The Sadguru Charitable Blood Bank Centre will Send Blood and Blood Products as per Indent to be mailed from time to time on a Daily Basis or as determined by the Blood storage Facility, the Hard copy of which will be picked up while delivering the Products.

The authorization / Indent letter from MGM HOSPITAL & RESEARCH CENTRE will be for all the Recipient samples being sent for availing Blood and/ or other Products.

2. The responsibility of the Grouping and Cross Matching and issue of the Blood and Blood Products shall be with the Storage Facility at the MGM Hospital & Research Blood Storage Centre, Vashi.

i. The charges for the Blood & Products shall be as follows:

1. Whole Blood:	Rs. 900/-
2 Packed Cells:	Rs. 900/-
3. Fresh Frozen Plasma:	Rs. 300/-
4. Random Donor Platelets:	Rs. 300/-
5. Reservation	Rs. 100/-
6. Single Donor Platelets:	Rs. 9000/- (No need for Pheresis Donor)

ii. Any change in charges for the above will be informed to MGM HOSPITAL & RESEARCH CENTRE on a routine basis.

iii. MGM HOSPITAL & RESEARCH CENTRE guarantees to settle the bill within 15 days from the date of receipt of the bills.

iv. MGM HOSPITAL & RESEARCH CENTRE will provide the Sadguru Charitable Blood Bank, Koparkhairane with the following.

- Sample of the letter of authorization on MGM HOSPITAL & RESEARCH CENTRE letterhead.
- A list of authorized signatories with their specimen signature shall be presented to the Blood Bank. MGM HOSPITAL & RESEARCH CENTRE would send an update to the Blood Bank periodically if there are any changes.

4. MGM Hospital & Research Centre will record the following quality indicators in the bags procured from Sadguru's Blood Centre for quality purpose as per the following schedule.

Quality Indicators:-

1. Random testing (HIV, HCV, HBSAG, MP, VDRL & Culture) of Blood components procured from your Blood Centre.
2. Percentage for Fresh Frozen Plasma (FFP) bags showing leakage post thawing.
5. Site visit by technical team of the department will be done annually.
