**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS :-**

1. NMMC hereby grant unto MGM Medical College, Vashi their permission to use the said premises to supplement healthcare to the user of MCH Centre Turbhe and its affiliated Urban Health Posts such as Turbhe Stores /Indiranagar and its entire field practice area and also training of Medical & Paramedical students, Post-graduate residents, Interns, Nurses and other Paramedical Staff in Urban Community Health Care Centres for period of 5 years.

2. MGM Medical College, Vashi shall use the PREMISES for the specific purposes as Outlined in Para 1.

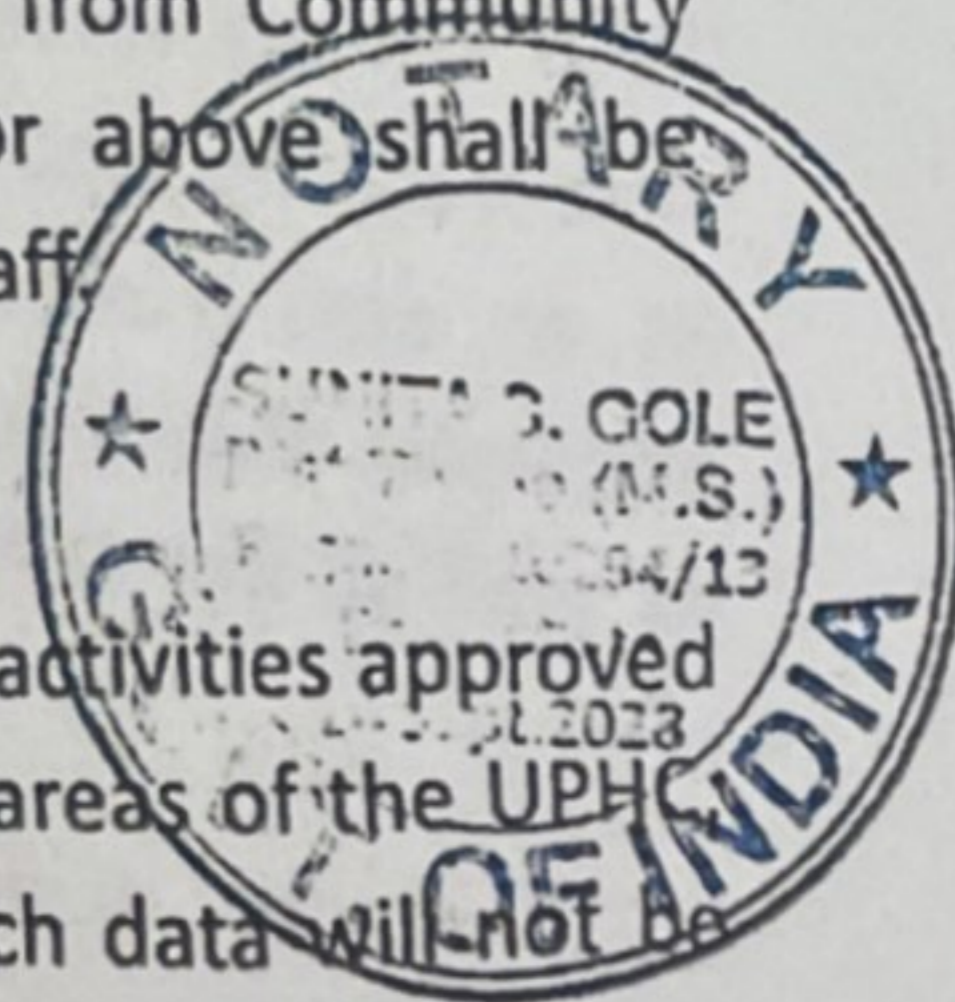
3. NMMC will provide all facilities to MGM Medical College, Vashi in the existing infrastructure of centre including OPDs, Wards. Operation theatre, X-ray. USG, Dressing Room, Injection Room etc. MGM Medical College, Vashi will help in the patient care and also to hold health talks, health checkup camps, exhibitions and any other activity for community health care as required by Regulatory bodies.

4. MGM Medical College, Vashi shall provide Independent Unit With services of qualified doctors, residents and interns from various specialties in a phased manner. Eventually, within a span of 2-3 months, the MGM Medical College, Vashi would establish a unit consisting of Obstetrician and Gynaecologist, Pediatrician, Anesthetist and allied staff at MCH Centre Turbhe. The Unit would operate OPDS, OT and emergencies on two days in a week, but NMMC will not pay for salary Doctors/Staff provided by MGM Medical College, Vashi.

5. MGM Medical College, Vashi will provide faculty from Community Medicine with designation of Assistant Professor or above shall be academic in-charge of the UHTC and PHN and other staff.

6. MGM Medical College, Vashi can conduct research activities approved by Institutional Ethics Committee at in field practice areas of the UPHC But prior permission of NMMC required and research data will not be published without prior permission of NMMC.

7. For all the academic, research and extension activities mentioned above, the Dean, MGM Medical College, Vashi shall have overall control.

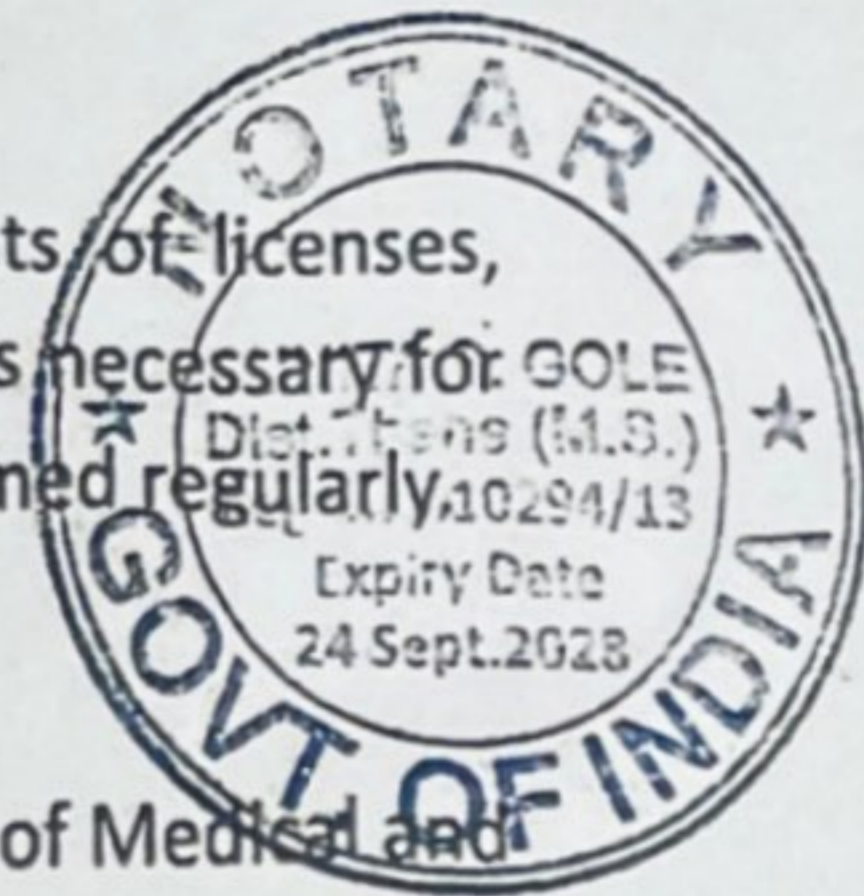
8. NMMC shall continue to have administrative control over the MCH centre and UPHC functions as per NMMC norms while MGM Medical College, Vashi shall have academic control over the UHTC.

9. NMMC will ensure that medical & paramedical staff of the MCH Centre & UPHC and other field staff shall work in close coordination with MGM Medical College, Vashi for provision of outreach activities, treatment and referral services. MGM Medical College, Vashi will attempt to add value to the existing services for betterment of the community.

10. NMMC will provide office space, training area and rest-rooms in the said premises for staff & students of the MGM Medical College, Vashi.

11. MGM Medical College, Vashi shall help the NMMC in extending any other specialty service in their locality.

12. NMMC shall ensure that the statutory requirements of licenses, approvals from the Government and local Civil Authorities necessary for operations and treatment of all kinds of patients are obtained regularly.



13. MGM Medical College, Vashi shall extend the services of Medical and Paramedical staff on as required basis and only during appointed hours. Provision of emergency care, ambulance, transportation etc shall continue to be provided by NMMC. MGM Medical College, Vashi shall help in providing/coordinating secondary and tertiary care at its teaching hospital at Vashi But Responsibility and legal liability related to management of patients at MCH Turbhe by MGM Unit will be bear by MGM Medical College, Vashi itself.

14. If any dispute arises between the parties hereto in respect of the agreement or in the connection if any claim by one against the other, the same shall be referred to the commissioner of NMMC whose decision shall be final.
