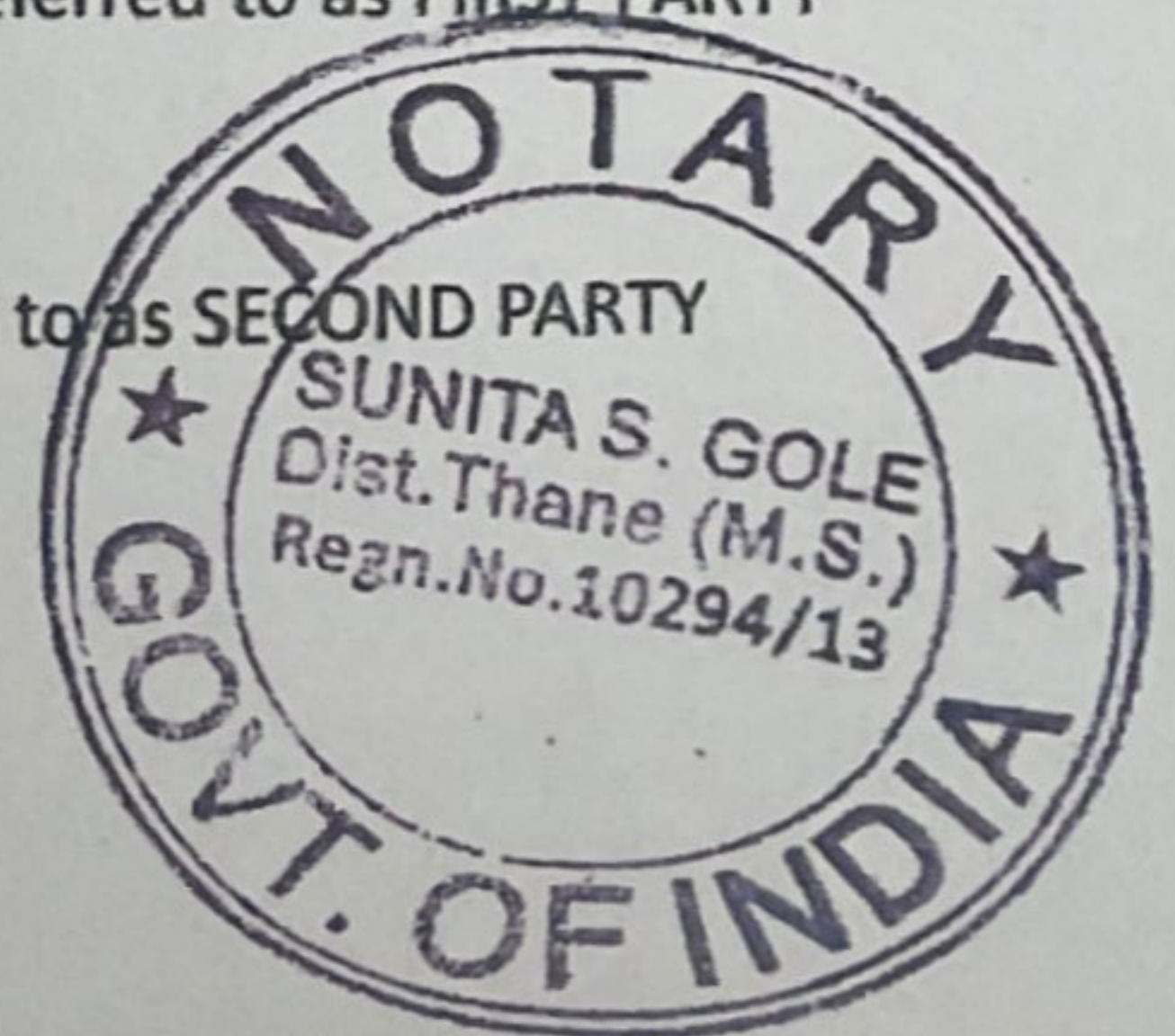

This MOU is made at Navi Mumbai and comes in effect from 25th Day of October 2023 between  
PRIMARY HEALTH CENTRE, KOPROLI, DISTRICT- RAIGAD, hereinafter referred to as FIRST PARTY

AND

MGM MEDICAL COLLEGE, VASHI, NAVI MUMBAI, hereinafter referred to as SECOND PARTY

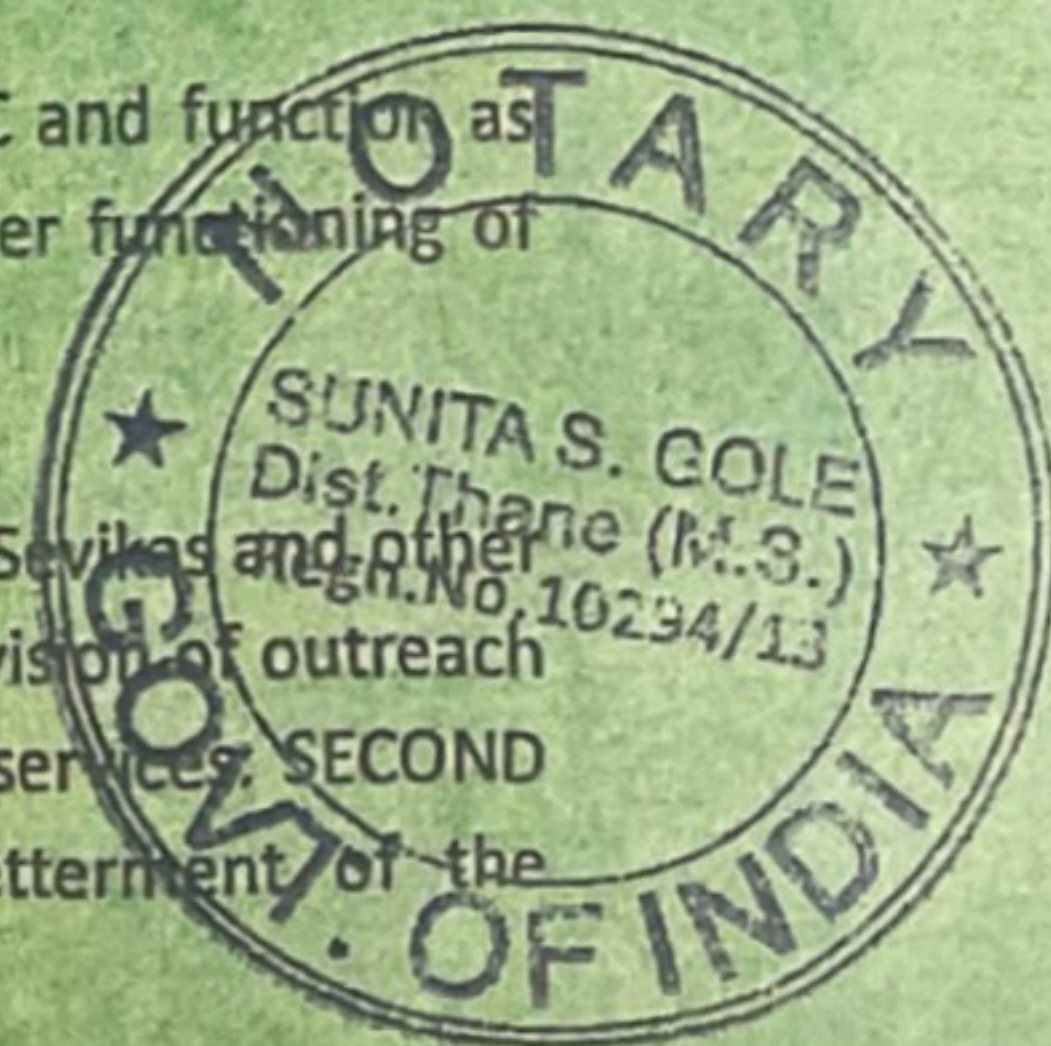
AND WHEREAS THE FIRST PARTY is seized, possessed of and sufficiently entitled to the Primary Health Centre (PHC) at Koprolī Village, Uran Taluka, Dist Raigad, hereinafter referred to as the SAID PREMISES which is in their exclusive possession

AND WHEREAS the SECOND PARTY has approached FIRST PARTY for permission to use the said premises for teaching of medical and / or paramedical students and staff AND setting up of Rural Health Training Centre at the said premises.

NOW THIS AGREEMENT WITNESSETH AS UNDER:

1. The FIRST PARTY hereby grant unto the SECOND PARTY their permission to use the said premises to render healthcare to the users of Primary Health Centre, Koprolī, constituent sub-centres and its entire field practice area and also training of Medical & Paramedical students, Post-graduate residents, Interns, Nurses and other Paramedical Staff in Community Health Care with effect from 1<sup>st</sup> Nov 2023 for a period of minimum 5 years.
2. The SECOND PARTY shall use the PREMISES for the specific purposes as outlined in Para 1. The said premises will be designated as "Rural Health Training Centre (RHTC)"
3. The FIRST PARTY will provide all the facilities to the SECOND PARTY in the existing infrastructure of centre including OPDs, Wards, Operation Theatre, X-Ray, Dressing Room, Injection Room, Labour Room, Immunization etc for helping in the patient care and also to hold health talks, health checkup camps, exhibitions and any other activity for community health care as required by Regulatory bodies.
4. SECOND PARTY will provide services of qualified doctors, residents and interns from various specialties as and when required.
5. SECOND PARTY will also provide outreach services to the population such as Family Adoption Program, Health education, Health camps as planned in consultation with FIRST PARTY and concerned authorities.
6. The FIRST PART shall also allow SECOND PARTY to conduct research activities approved by Institutional Ethics Committee at PHC, sub-centres and field practice areas of the PHC.
7. For all the academic, research and extension activities mentioned above, Department of Community Medicine, MGM Medical College, Vashi, Navi Mumbai will be coordinating agency. Faculty of the level of Assistant Professor or above shall be designated as "RHTC In-Charge" who will coordinate with MO In-Charge of PHC for day-to-day functioning.
8. FIRST Party shall continue to have administrative control over the PHC and function as per Govt norms while SECOND PARTY shall have Academic control over functioning of RHTC.
9. The FIRST Party will ensure that staff of the PHC, ASHA and Anganwadi Sevikas and other field staff shall work in close coordination with SECOND PARTY for provision of outreach activities (such as Family Adoption Program), treatment and referral services. SECOND PARTY will attempt to add value to the existing services for betterment of the community.
10. The FIRST PARTY will provide accommodation (well furnished minimum 2 rooms) in the said premises for Resident doctors and Interns.

11. The FIRST PARTY has no objection to the use of said premises and sharing relevant health data for the purpose of teaching & research and reflecting the same in documents submitted to authorities such as National Medical Commission, Nursing Council, University etc.
12. SECOND PARTY shall help the FIRST PARTY in extending any other specialty service in their locality.
13. The FIRST PARTY shall ensure that the statutory requirements of licences, approvals from the Government and local Civil Authorities necessary for operations and treatment of all kinds of patients are obtained regularly.
14. The SECOND PARTY shall extend the services of Medical and Paramedical staff on as required basis and only during appointed hours. Provision of emergency care, ambulance, transportation etc shall continue to be provided by the PHC. SECOND PARTY shall help in providing / coordinating secondary and tertiary care at its teaching hospital at Vashi / Kamothe.
15. This agreement can be terminated by either party by giving 3 months' notice without mentioning any reason for termination.
16. All Medico-Legal cases shall be dealt with by the Medical Officer of PHC (FIRST PARTY).
17. Provision of medicines, instruments in OPD, IPD, OT, Labour room etc including maintenance shall be responsibility of FIRST PARTY.
18. Any dispute relating to this agreement shall be subject to jurisdiction of courts at Raigad district only.

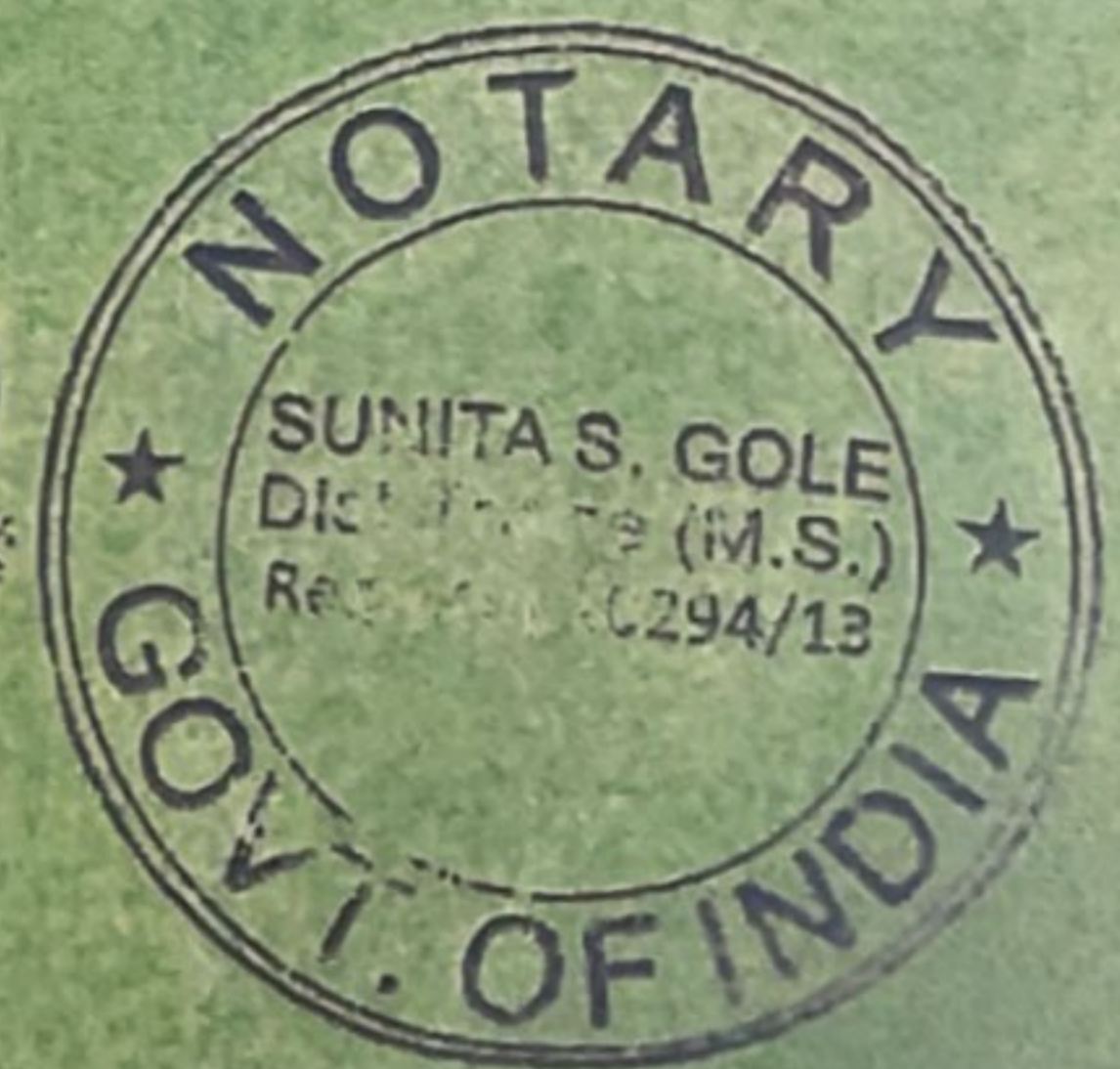
