Instructions for students reporting for MBBS admission 2020-21 at constituent Medical **Colleges of MGMIHS**

All NEET UG - 2020 Qualified Students who are eligible to report in the counseling rounds of DGHS/MCC for Under graduate (MBBS) program (Academic Year 2020-21), are hereby informed that they have to report to the respective Constituent Medical Colleges of MGM Institute of Health Sciences, Navi Mumbai or Aurangabad, as allotted to them by DHGS/MCC.

Management Quota:

- The students should pay the Tuition Fees of first year i.e. Rs. 20,00,000/- (Rupees Twenty Lakh Only) in the form of Demand Draft only. Demand Draft must be made in favor of "MGM Institute of Health Sciences" payable at Mumbai. Multiple DD's totaling to Rs. 20 lakhs are
- Kindly note that the annual tuition fees of Rs. 20,00,000/- will remain same for the entire duration of course ($4\frac{1}{2}$ year).
- If fees, is to be paid by RTGS, student must report first to the respective medical college and submit the document. After verification of documents, he/she will be provided with RTGS details.

NRI Quota:


- The students should pay the Tuition fees of first year i.e. Rs. 45, 00,000/- (Rupees Forty five Lakh only) (An equivalent amount to be paid in US dollars) in the form of Demand Draft from his/her /Sponsorer's NRI Bank Account OR Wire Transfer. Demand Draft must be made in favor of "MGM Institute of Health Sciences" payable at Mumbai.
- Regarding NRI Quota, the directions passed by the Hon'ble Supreme Court of India in W.P. (C) No. 689/2017 dated 22.08.2017 in the case of, Consortium of Deemed Universities in Karnataka (CODEUNIK) & Anr. Vs. UOI & Ors. Should be followed.
- Interested & eligible NRI students (as per above directions of Hon'ble Supreme Court of India) are advised to register as 'NRI' quota candidate at the initial stage of registration on MCC website to avoid the delay / disqualification in the later stages of admission for NRI quota conversion.

The students must report to their respective colleges allotted, within the stipulated period given by DGHS/MCC in counseling schedule (available on www.mcc.nic.in) between 10:00 AM to 05:00 PM (Including Saturday and Sunday) along with fee Demand Draft and documents (All the original and two self attested photocopies as mentioned in the Annexure A attached with this notification) to complete the


