2. For admission at both above medical colleges, counseling will be done at MGM University Headquarter at Navi Mumbai.

4. Only those students who remain present at reporting time and found to be eligible as per MCC/DGHS wait list will be considered for counseling and admission.
5. Accordingly, a local merit list will be prepared based on which admission process will be conducted.
6. If the vacant seats get filled completely midway, than the counseling process will be stopped immediately and remaining students present on that day will not be considered for admission counseling.
7. Mere enlistment in the Institutional Stray Vacancy Round list of MCC/DGHS does not mean admission confirmation. Admission will be confirmed only after verification of all original documents and payment of fees.
8. No cancellation is permitted for admission taken through this Institutional Stray Vacancy Round at institute level.
9. Regarding NRI Seats, the directions passed by the Hon'ble Supreme Court of India in W.P. (C) No.689/2017 dated 22.08.2017 in the case of, Consortium of Deemed universities in Karnataka (CODEUNIK) & Anr. Vs. UOI & Ors. should be followed.
10. Candidate (himself/herself) must be present for Institutional Stray Vacancy Round of M.B.B.S. Admission. No proxy will be allowed under any circumstances. Along with students parents will only be allowed in the reporting venue.

Apart from the above documents: following need to be produced:-

- i. Notarized Affidavit of the person who is NRI and the Sponsorer
 - ii. Documents claiming that the Sponsorer is an NRI (Valid Passport, VISA & Indian Embassy letter situated in that country)
 - iii. Relationship of NRI with the candidate as per the court order of the Hon'ble Supreme Court of India in W.P. (C) No.689/2017 in the case of, Consortium of Deemed universities in Karnataka (CODEUNIK) & Anr. Vs. UOI & Ors. dated 22.08.2017 (Notarized Affidavit of Family Tree)
 - iv. Affidavit from Sponsorer that he/she will sponsor the entire course fee of the candidate
 - v. Bank Statement or cancelled cheque of the Sponsorer's NRI account from which fee will be paid.
12. The students should pay the Tuition Fees of **Rs. 20,00,000/- (Rupees Twenty Lakhs Only)** (For Management Quota) in the form of Demand Draft only. Demand Draft must be made in favor of "**MGM Institute of Health Sciences**" payable at Mumbai.
13. The students should pay the Tuition Fees of **\$ 60,000/- (Sixty Thousand USD Only)** (For NRI Quota) in the form of Demand Draft from his/her NRI Bank Account OR Wire Transfer.
14. Fee payment through RTGS is permitted only after documents verification (For exceptional cases only). Admission will be confirmed only after the receipt of fees in our bank account.
