Dear Sir/Madam,

In continuation of the above subject & reference, this is to inform you that scrutiny of the online submitted documents by students for eligibility process has been completed. Based on the status of the submitted documents by students, eligibility status have been categorised as follows:-

- A. Eligibility form and documents found to be correct (Status : Accepted).
- B. Documents incorrect / not relevant /not readable (Status : Rejected) (Annexure 1).
- C. Students who have not filled the online eligibility form (Status : Not submitted) (Annexure 2).
- D. Students who have not paid the eligibility fee through their online eligibility login portal (Status : Not submitted).
- E. Student who have not paid the 1st year tuition fee in full without valid approval (Status : Accepted but PRN will not be assigned untill 1st year tuition fees paid in full)

Accepted or Rejected status is displayed in the student login zone on the website.

Therefore, following actions are being initiated:-

- For rejected category students :- 'As per the deficiencies shown in the student's login, concerned student need to upload / re-upload the necessary documents in the stipulated time period from 17 May, 2024, 09.00 am to 25 May, 2024 up to 05.00 pm. No penalty will be charged if re-submitted documents are found to be correct / relevant / readable.
- 2. Not submitted category students :- Students who have not submitted the online eligibility form can also complete the process from 17 May, 2024, 09.00 am to 25 May, 2024 up to 05.00 pm. No penalty will be charged from these students if submitted documents are found to be correct / relevant / readable and eligibility fee is paid through online eligibility login portal. (Student who are unable to pay the eligibility fee through their online eligibility login portal need to inform to the undersigned with valid reason and only justifiable reason will be entertained)

In the 1st week of June, 2024, PR Numbers will be issued to those students who have completed the eligibility process successfully with 'Accepted Status' and also have paid tuition fees of 1st year in full.

Remaining students (Status Rejected / Status Not submitted / Status Not assigned) will not be issued PR Numbers untill they fulfill all needful requirements. Thus, with effect from May 26, 2024 academic term will not be granted to such students and also they will not be able to fill the University examination form due to lack of PR Numbers eventually.

It is important to note that the documents which are to be submitted for eligibility were already known to the students / institutes as thay are all mandatory documents for admission process itself. The process of admission started in November 2023 thereby students were clearly having 6 to 7 months time to mobilise required documents untill now. Therefore, no excuses or reasoning will be entertained by University from such students after May 25, 2024. All these students will get the PR Numbers only when they complete the eligibility process with applicable penalty with effective from May 26, 2024.

All such students admitted in the academic year 2023-24 (DM/MCh) may be informed about above at the earliest to initiate necessary action from their side to avoid the academic inconvenience for which they will be solely responsible due to non-compliance.
