

Department of Anatomy, MGMMC Navi Mumbai has cold storage facility and storage of fresh cadavers at -20 degree Celsius. These cadavers can be used to study newer techniques in the field of surgery, gynaecology, pain and anaesthesia through the hands on workshops on the terms and conditions, wherein below:

Whereas in order to train the doctors, department of Anatomy MGM MC NM intend to tie-up with INS – IM 2020 for providing collaborative hands on workshop in neuro-modulation.

(B) INS – IM 2020 is who conducts workshops to train doctors in the field of neuro-modulation.

(C) Pursuant to various meetings and discussions the MGMIHS and INS - IM 2020 will impart training, generate able and guiding knowledge, experience and its expeditious dissemination for the patient's benefit. The parties will make efforts and take steps to ensure that the objectives under the present MOU are achieved and agree to provide all reasonable cooperation in meeting this objective.

NOW THEREFORE THESE PRESENTS WITNESSETH IT IS AGREED BY AND BETWEEN THE PARTIES HERE TO AS FOLLOWS

Obligation on part of Department of Anatomy, MGMMCH:

Department of Anatomy, MGMMCH will provide:

- a) Dissection hall with AC
- b) Lecture hall (Ground floor) with AV & AC
- c) 10 fresh cadavers stored at -20°C with Triple 'H' & COVID testing.
- d) 2 functional C-arm machines
- e) 5 wooden tables
- f) 5 platforms to stand
- g) 15 lead gowns.
- h) MGMMC, NM will provide MGM logo to INS – IM 2020.

*All the charges are made free as suggested by MGM trustee / MGMIHS

Obligation on part of INS – IM 2020

INS – IM 2020 will provide:

1. MGMMC, NM will be an academic partner & its name will be in brochures & cadaver course certificates and acknowledged in all collaterals and vote of thanks.
2. Catering service, 3 C-arm machines & protective gears will be arranged from INS – IM 2020.

2. Terms and Conditions of the Program

1. The workshop program will be on 10 cadavers. Delegates will be divided in two batches. Hands on will be done in dissection hall by first batch and discussion will be in lecture hall for second batch simultaneously. All aspects of Neuromodulation and guided procedures will be covered under supervision. The program will start at 8 am and ends at 5 pm on 11th November 2022.

3. Responsibilities / Duties of INS -IM 2020:

1. INS – IM 2020 will provide a complete set of the instruments and scopes. This will remain the property of INS – IM 2020 and INS – IM 2020 is entitled to withdraw or take away
2. MGMMC, NM will be an academic partner & its name will be in brochure & cadaver course certificates of workshop and acknowledged in all collaterals and vote of thanks.
3. Catering services, 3 C-arm machines & protective gears will be arranged from INS – IM 2020.
4. Quadrangular area will be provided for catering services.

4. Responsibilities of MGMIHS:

1. 10 fresh cadavers stored at -20 degree will be provided to delegates in two batches to avoid putrefaction smell. All the cadavers will be tested for Triple 'H' & COVID. After first session the cadavers will be kept in deep freezer immediately with no time loss.
2. 2 functional C-arm machines, 5 wooden tables, 5 platforms to stand, 15 lead gowns will be provided to carry out workshop smoothly and effectively.
3. Lecture hall on the ground floor with AV and AC will be provided from 8 am to 5pm on 11th November 2022 where all the interactive sessions will be conducted.
4. The certificate for the program will be issued jointly by MGMIHS and INS – IM 2020.

5. General conditions

1. The MOU will be valid for a period of 1 year from the date of execution of the MOU to ensure smooth conduction of the program the parties may further extend renew the MOU on terms and conditions as a mutually agreed.


g. Amendments
