

Report of fitment of Myo-electric Prosthesis to a student of MGMIHS

Title: Fitment of Myo-electric Prosthesis to a student of MGM School of Biomedical Sciences, Kamothe, Navi Mumbai.

Purpose: To extend a helping hand to a congenital Trans-radial Amputee student of MGM School of Biomedical Sciences, Kamothe, Navi Mumbai.

Venue: MGM Institute's University Department of Prosthetics and Orthotics.

Date of fitment: 26/05/2022.

Departments: MGM Institute's University Department of Prosthetics and Orthotics, Navi Mumbai and MGM School of Biomedical Sciences, Kamothe, Navi Mumbai.

Proceedings:

Mr. Satish Salunkhe, a student of MGM School of Biomedical Sciences, Kamothe, Navi Mumbai is a Trans-radial Amputee by birth. He had taken admission to B.Sc. M.R.I.T in the Academic Year 2019-20.

He was performing his activities of daily living quiet smoothly. But as he was a Trans-Radial Amputee, at some stages, he was finding himself incomplete. His incompleteness was observed by Dr. Mansee Thakur, Director of his college.

At the same time, a Continuing Rehabilitation Education (CRE) Program on 'Advancements in Myoelectric Prostheses' was conducted by the Department of Prosthetics and Orthotics at MGM Institute of Health Sciences. In this CRE program, all trainers who fitted artificial hands with high technology and advanced components (Myo-Electric prosthesis) for various patients in India, had arrived from Super Motorica, which is a Moscow based company.

A thought was given to fit this Myo-electric Prosthesis to Mr. Satish Salunkhe who was in need of such support.

Continuing the Gandhian Philosophy followed by MGM Institute of Health Sciences, "To wipe tears from everyone's eye", the Management decided to provide Mr. Satish with this hand and fulfil his deficiency with a realistic Prosthesis!

The measurements were taken in the month of January 2022 and the further procedure of fabrication was started in the month of February. The first trial was taken in the Month of March 2022.

Here, we would like to put forth that because the student is from MGM Institute of Health Sciences (which is very prestigious organization and they did not want to take any kind of risk), the company wanted to fit his Prosthesis only by experts from Moscow. The mail explaining the same is attached herewith.

The trials were continuously going on in the following months of March and April, but the department of Prosthetics and Orthotics felt that there was an improvement required with the fitment.

Finally with all the efforts and fine tuning, the final fitment was done on 26th May 2022 and the Prosthesis was delivered to Mr. Satish Salunkhe with proper training by the experts of Motorica and MGM Department of Prosthetics & Orthotics.


