

The Anti Ragging Committee meeting started at 2PM in Ground Floor Conference Hall of MGM Medical College, Kamothe, Navi Mumbai..

Chairman welcomed all the Committee members and the meeting started.

Dr. Shilpi Sahu, Nodal Officer, has read the complaint received from the Anti Ragging Helpline vide No., ARCC/MH-7264 Dated: 02/04/2022 by giving a copy to each member. As pe the Complaint the victim is from Department of Anaesthesiology. And got some issues with Senior Faculty Dr. Sathe & Mrs. Sathe. of the same department. The name of the complainant is not given nor did the same mention in the compliant..

Chairman (Dean) has informed the members of the Anti Ragging Committee that, after receiving the E-Mail from the Anti Ragging help line, the following action has been taken as a prima facie.

- a) The Senior Faculty member Dr. Vishwas Sathe & Dr, Mrs. Deepali Sathe from Department of Anaesthesiology has been kept away from the department and duties till the ARC report recommendations.
- b) All the Resident Doctors JR-I, II & III were called and counseled, so that they feels safe and the Committee members assured them that the authorities are with them & the complaint will be scrutinized and the identity will not be revealed, since we do not know the complainant.

The Committee discussed the Complaint and started the investigation.

All the Junior Resident-I, J-II & JR-III have been called for interaction with ARC members and given chance to reveal, if there is any untoward situation is happening or happened in their department, one by one separately

They have been given confidence that they can express their views towards the complaint since the complainant is not known. They have been asked individually in the meeting whether they have any complaint against any of the seniors or any thing. Whether any body has harassed them mentally or physically. Any other problem with Dr. Sathe & Dr. Mrs. Sathe like:

- a) Thretening like continuous On Calls
- b) Statement like We shall see you in you exams
- c) Etc. as mentioned in complaint. .

All JRI, JR-II, JR-III Resident Doctors have given statement to the Committee that they have no clue of that. All of them denied, that any form of harassment or Threatenings like continuous Calls etc. or work pressure from the Department of Anaesthesiology any o the faculty..

After the interrogations, the Committee members have given their views about the Complaint as follows :

All members of the Committee clearly pointed out that this is not to be considered as ragging. Due to work pressure and the adjustment problem in work place to do clinical duties.

Dr. Nath also supported to that One Full batch who all are supposed to come in April-May 21 has joined in Feb-March 2022. This may have caused a lot of work pressure in all departments among Resident Doctors., which is to be noted

Dr. Shilpi felt that this incident is not under preview of ARC, however going to the grievous nature of the complaint the issue has to be handled sensitively and the entire batch has been counseled separately.

Dr. Ghanekar madam told that all resident doctors should be further couselled to address work pressure and personal issued with faculty at regular intervals. Mentor Mentee meeting should be more frequent.

The Police Officer Madam has shared her contact number with all the PG Students, that if they want to share any issue regarding the complaint, they are free call any time and share their problem related to this complaint.

Dr. Vishwas Sathe & Dr. Deepika Sathe Faculty from Anaesthesiology has been called and interacted by ARC on the same day after interactions with students. The Nodal Officer read the Complaint to him and asked about the explanation and views:-

He strongly denied all the points mentioned in the complaint and has expressed that he shared cordial relation with all the residents in his department, and Both of them confidently assure that these allegation against them are very False, The statements written by them are also attached.

- Inter Departmental meeting should be conducted routinely and allow them to share all the complaint and their problems with PG Guide/ Mentor/ HOD in time & minimum once a month so that they are relaxed in their issues of personal and work and do their residency more efficiently.
- 4. The Committee arrived at the conclusion that the allegations against Dr. Vishwas Sathe & Dr. Mrs. Deepika Sathe has no substance, Hence they may be allowed them to continue their duties asemergencies and OT Services.
