Meeting started with greeting the Chairperson.

Dr. Prabha Dasila, Professor and Director chaired the meeting.

Dr. Jyoti Chaudhari, secretary read the minutes of the previous meeting.

While answering the initiatives taken by the committee, Dr. Jyoti Chaudhari reported that induction programme was conducted to fresh batches of undergraduate and postgraduate nursing students which included anti-ragging policy of the organization. Last year, posters on antiragging act were displayed on various floors of college building and in the hostel too. She also reported that, this year antiragging forms were not yet filled by the students. The chairperson told to provide necessary instructions to class coordinators of concerned batches. The minutes of the previous meeting were passed by Ms. Sarika Nair and seconded by Ms. Derlin Thomas.

Item 1: To welcome the new members to anti ragging committee-

After a brief introduction of the members, the chairperson welcomed the new student and faculty member.

Item 2: To make the students aware of anti-ragging policies, functions of committee and squad.-

Discussion: The secretary explained antiragging policy of MGMNB CON. She also explained forms of ragging and punishments for indulging in ragging activity. Furthermore, the chairperson discussed the role of anti-ragging committee, anti-ragging squad and role of a student member. Student member showed willingness to pass antiragging related information among the batch mates and to be vigilant.

Resolution: Student member will share the resolutions taken in the meeting with peer. They will interact with the peer and disseminate the information about ragging, its consequences and antiragging policy adopted by the college.

Item 3. To discuss about how to maintain ragging free environment and develop trust among new batch of students to report ragging activities if any –

Discussion: Dr. Jyoti Chaudhari, Secretary highlighted the various activities undertaken uptill now by the committee such as display of antiragging posters at various floors of college building as well as in the hostel. Last year, antiragging squad took rounds in the hostel and also took weekly surprised rounds in the college premises. She also acknowledged the efforts of last year committee, as there was no such case observed or reported among Nursing students. Regular student teacher interaction, senior students as peer mentors in the hostel, maintaining interpersonal relationship, instillation of the complaint box, and display of posters regarding kind of punishment in case of ragging were the few activities suggested by the student representatives. In response to this, Chairperson said that there is already one complaint box in the office kept for the student. She also mentioned that complain box must be regularly opened. One of the members suggested creating online form to file complaint against ragging. However, other suggestions like mentoring by peers and maintain interpersonal relationship was appreciated.

Resolution: Complaint box which already exists in the Office will be shifted in the staircase at fifth floor for easy access. In order to avoid delay in urgent and sensitive matter it needs to be informed immediately to class teacher or friend and /or to anti-ragging committee member.

Student members were appealed to report occurrence or suspiciousness of ragging activity in the college campus to the committee members directly or through class teachers /mentors. In such case high priority meeting will be conducted to listen to both parties for taking necessary action. Committee also decided to continue with measures taken regularly. Squad committee will make rounds regularly to isolated places in the college, campus and hostel.

With this meeting was adjourned at 4 pm after thanking the chair.
