In exercise of the powers conferred by Section 3 of the University Grants Commission Act, 1956, the Central Government, on the advice of the University Grants Commission, hereby declare the MGM Institute of Health Sciences, Navi Mumbai consisting of two constituent medical colleges i. e. i) Mahatma Gandhi Mission's Medical College, Navi Mumbai (Maharashtra) and ii) Mahatma Gandhi Mission's Medical College, Aurangabad (Maharashtra) as Deemed to be University for the purpose of the aforesaid Act, provisionally, for a period of five years, from the date MGM Institute of Health Sciences, Navi Mumbai disaffiliates its Mahatma Gandhi Mission's Medical College, Navi Mumbai from Maharashtra University of Health Sciences, Nasik for its under graduate courses and from University of Mumbai for its post graduate courses and disaffiliates its Mahatma Gandhi Mission's Medical College, Aurangabad (Maharashtra) from Maharashtra University of Health Sciences, Nasik for its under graduate courses and from Dr. Baba Saheb Ambedkar Marathwada University, Aurangabad for its post graduate courses and subject to conditions mentioned at S. No. 7 of the endorsement of this notification. This declaration is also subject to review by a Review Committee to be appointed by the University Grants Commission (UGC).

2. Government of India or the University Grants Commission will not provide any Plan or Non Plan grants to the MGM Institute of Health Sciences, Navi Mumbai or any of its constituent institutions.



Sir,

I am directed to refer to the UGC's letter No.30-8/2009 (CPP-I/DU) dated 23rd August, 2019 w.r.t. starting of the following seven Departments/Constituent Units by MGM Institute of Health Sciences, Navi Mumbai without approval of the UGC:

- i. MGM New Bombay College of Nursing, Navi Mumbai;
- ii. MGM School of Physiotherapy, Navi Mumbai;
- iii. MGM School of Biomedical Sciences, Navi Mumbai;
- iv. MGM Institute's University Department of P&O, Navi Mumbai;
- v. MGM College of Nursing, Aurangabad;
- vi. MGM School of Physiotherapy, Aurangabad; and
- vii. MGM School of Biomedical Sciences, Aurangabad.

2. Keeping in view the following facts, the Expert Committee of UGC recommended that this Ministry may treat the above mentioned Departments as Constituent Units of MGM Institute of Health Sciences, Navi Mumbai:

- i. MGM Institute of Health Sciences, Navi Mumbai was declared as Deemed to be University consisting of two Medical Colleges.
- ii. The Deemed University had started Courses in the field of Health Sciences such as Biomedical Sciences, Physiotherapy and Nursing at its Navi Mumbai and Aurangabad Campus. All these courses are allied to the medical sciences.
- iii. The Courses in Nursing were started with the approval of Indian Nursing Council (INC) and Prosthetics and Othrotics were started with the approval of Rehabilitation Council of India (RCI). There is no Council for Physiotherapy and Courses in Biomedical Sciences are general courses.

- iv. The Deemed University has fulfilled the conditions of this Ministry's letter dated 26.04.2018.
 - v. The Deemed University is accredited by NAAC with A grade.
3. Based on the recommendation of the UGC, this Ministry conveys its approval for running of the above mentioned Departments as Constituent Units of MGM Institute of Health Sciences (Deemed to be University), Navi Mumbai.
 4. This issues with the approval of competent authority.
