4. The Bank Guarantee(s) shall be valid for more than three years (3.5 years) or two year (2.5 years), in case of Degree and diploma course respectively.

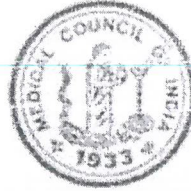
