

It is mandatory to develop a biometric attendance, website on the medical college/institution and display all the information of the college, courses offered, faculty available and their experience of the last 5 years, students joined, and affiliating university. To display the hospital services, facilities available and the equipment in each speciality, also showing OP and IP census including births and deaths as per the Municipal/Govt. records.

If any difference of information, you are requested to follow section 28(5) of NMC Act, 2019.


