Agenda Point No. 2: Action Taken Report of previous University IQAC meeting held on 7th November, 2023.

Dr. Rita M. Khadkikar confirmed the minutes with the action taken of the pervious IQAC meeting conducted on 7th November, 2023.

Agenda Point No. 3: Presentation of the draft report of AQAR 2022-23.

Dr. Rita Khadkikar presented draft report of AQAR 2022-23.

The NAAC HEI portal was displayed with the write ups, uploads and data templates

Part A, NEP implementation and Extended profile data were presented.

Part B Criterion wise data was presented and comparative of the previous 2 years (quantitative data) was displayed

The following suggestions were made

- Dr. P M Jadhav enquired regarding achievement of benchmarks. He suggested that at least 5 programs need to be introduced every year.
- Dr. Goel suggested that students should be encouraged to enroll for more Value added courses. Hon'ble VC sir suggested to upload all VAC certificates on the portal.
- Hon'ble VC sir and Registrar sir enquired about uploading of the feedback of all the stakeholders along with Action taken reports on the website.
- Dr. P M Jadhav suggested that the feedback proforms should be only restricted to the curriculum. Dr.Rita Khadkikar mentioned that Student satisfaction survey in Criterion 2 was focused on the curriculum but feedback in criterion 1 includes all other aspects like facilities provided, environment on the campus etc.
- Regarding enrollment of student profile in criteria II Hon'ble VC sir suggested to include students with NRI status.
- Hon'ble VC suggested a team to verify awards related to 2.4.5 and validate the teacher recognitions and awards. He also emphasized that the infrastructure details should have the evidences. He suggested that each year there should be initiative for inculcating new best practices and Institutional distinctiveness.
- In best practices the outcome should be reflected using quantitative figures and that they should align with the objectives.
- There was suggestion to add industry- academia collaboration in future plans.
