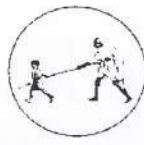

Hon'ble Vice Chancellor presented the difference between AQAR based on Health Sciences Manual (7 Criteria) and the new reforms (10 attributes). The reforms focus on Inputs-Process-Outcomes-Impact.

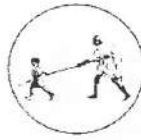
He emphasized on certain attributes that we need to enhance. He mentioned the maturity based graded levels

Dr. Rita M. Khadkikar gave details of

- The Pillars of higher education commission of India (HECI)
- Draft on transformative reforms for strengthening assessment and accreditation of HEI in India
- Levels (Brief description) maturity based graded levels
- One National accreditation council (NAC)-for approval ranking and accreditation
- One framework with 10 attributes (68 metrics each with multiple parameters)
- One nation one data (ONOD)
- Diverse vectors will be generated from one data
- For ranking inputs and process is given more weightage
- For accreditation outcome and impact are important.
- Choice based ranking system for various stakeholders to take informed decision (students, funding agencies etc)
- Reaccreditation every 3/6 years
